- **SMISHING:** SMS PHISHING THAT INVOLVES SENDING TEXT MESSAGES TO TRICK INDIVIDUALS INTO PROVIDING PERSONAL DATA.

UNDERSTANDING THESE TACTICS IS ESSENTIAL FOR DEVELOPING EFFECTIVE TRAINING PROGRAMS AND RESPONSES.

- SECURITY ALERTS: EMAILS THAT CLAIM THERE HAS BEEN SUSPICIOUS ACTIVITY ON AN ACCOUNT, PROMPTING USERS TO LOG IN THROUGH A PROVIDED LINK.

RECOGNIZING PHISHING ATTEMPTS

TO PREVENT FALLING VICTIM TO PHISHING ATTEMPTS, EMPLOYEES SHOULD BE TRAINED TO RECOGNIZE KEY INDICATORS OF PHISHING EMAILS. THESE INCLUDE:

- SUSPICIOUS SENDER: EXAMINE THE SENDER'S EMAIL ADDRESS FOR DISCREPANCIES.
- GENERIC GREETINGS: PHISHING EMAILS OFTEN USE GENERIC GREETINGS INSTEAD OF PERSONALIZED MESSAGES.
- URGENT LANGUAGE: PHISHING ATTEMPTS FREQUENTLY EMPLOY URGENT LANGUAGE, PRESSURING RECIPIENTS TO ACT QUICKLY.
- MISMATCHED URLS: HOVER OVER LINKS TO VERIFY THAT THEY DIRECT TO LEGITIMATE WEBSITES.
- POOR GRAMMAR AND SPELLING: MANY PHISHING EMAILS CONTAIN GRAMMATICAL ERRORS AND UNUSUAL PHRASING.

HOW TO PREPARE FOR KNOWBe4 PHISHING TESTS

PREPARATION IS VITAL FOR SUCCESSFULLY NAVIGATING KNOWBe4 PHISHING TESTS. HERE ARE STEPS EMPLOYEES CAN TAKE TO ENHANCE THEIR AWARENESS:

5. STAY INFORMED: REGULARLY REVIEW UPDATES ON COMMON PHISHING TACTICS AND TRENDS TO REMAIN CURRENT ON EMERGING THREATS.

WHAT TO DO IF YOU FALL FOR A PHISHING ATTEMPT

EVEN THE MOST VIGILANT EMPLOYEES CAN OCCASIONALLY FALL VICTIM TO PHISHING ATTEMPTS. IF THIS HAPPENS, IT IS ESSENTIAL TO ACT QUICKLY:

- CHANGE PASSWORDS IMMEDIATELY: IF CREDENTIALS ARE COMPROMISED, CHANGE PASSWORDS FOR AFFECTED ACCOUNTS.
- NOTIFY IT OR SECURITY TEAM: REPORT THE INCIDENT TO THE ORGANIZATION'S IT OR SECURITY TEAM AS SOON AS POSSIBLE.
- MONITOR ACCOUNTS: KEEP AN EYE ON FINANCIAL AND ONLINE ACCOUNTS FOR ANY UNAUTHORIZED ACTIVITY.
- USE TWO-FACTOR AUTHENTICATION (2FA): ENABLE 2FA ON ALL ACCOUNTS THAT SUPPORT IT FOR AN ADDED LAYER OF SECURITY.

IN AN INCREASINGLY DIGITAL WORLD, THE IMPORTANCE OF PHISHING AWARENESS CANNOT BE OVERSTATED.
