RESULTS

50	14.0	1.4
75	17.3	1.73
100	20.0	2.0

A GRAPH PLOTTING LENGTH VS. AVERAGE PERIOD SHOWED A LINEAR RELATIONSHIP, CONFIRMING THE THEORETICAL PREDICTIONS.

DISCUSSION

THE RESULTS SUPPORTED THE HYPOTHESIS THAT A LONGER PENDULUM LENGTH RESULTS IN A LONGER PERIOD. THIS ALIGNS WITH THE THEORETICAL FORMULA FOR A PENDULUM'S PERIOD. DISCREPANCIES IN THE DATA MAY BE ATTRIBUTED TO AIR RESISTANCE AND THE PRECISION OF TIMING METHODS.
