DEVELOPING A LAB SAFETY MANUAL

- USE CLEAR, CONCISE LANGUAGE AND CONSIDER INCORPORATING VISUALS, SUCH AS DIAGRAMS AND CHARTS, TO ENHANCE UNDERSTANDING.

4. REVIEW AND REVISE

- SOLICIT FEEDBACK FROM LABORATORY PERSONNEL AND OTHER STAKEHOLDERS TO IDENTIFY AREAS FOR IMPROVEMENT.
- REVISE THE MANUAL BASED ON FEEDBACK AND ENSURE IT ADDRESSES ALL NECESSARY SAFETY CONCERNS.

5. IMPLEMENT TRAINING PROGRAMS
