SAMPLE LANDMARK SUPREME COURT CASES

- **IMPACT:** THIS LANDMARK DECISION SPARKED ONGOING DEBATES AND LEGISLATION REGARDING REPRODUCTIVE RIGHTS.

- **MIRANDA V. ARIZONA (1966)**

- **BACKGROUND:** THIS CASE INVOLVED THE RIGHTS OF INDIVIDUALS TAKEN INTO POLICE CUSTODY.

- **UNITED STATES V. NIXON (1974)**

- **BACKGROUND:** THIS CASE AROSE FROM THE WATERGATE SCANDAL AND THE ASSERTION OF EXECUTIVE PRIVILEGE.

- **LEGAL QUESTION:** CAN A PRESIDENT CLAIM EXECUTIVE PRIVILEGE TO WITHHOLD INFORMATION RELEVANT TO A CRIMINAL INVESTIGATION?
- **DECISION:** THE COURT RULED THAT THE PRESIDENT IS NOT ABOVE THE LAW AND MUST COMPLY WITH SUBPOENAS.
