FORMAT AND DURATION

ETHICAL PRINCIPLES AND STANDARDS

ETHICS PLAY A CENTRAL ROLE IN THE PROFESSIONAL CONDUCT OF LICENSED INDIVIDUALS IN CALIFORNIA. THE LAW AND ETHICS EXAM CALIFORNIA EVALUATES THE CANDIDATE'S GRASP OF ETHICAL STANDARDS AND THEIR ABILITY TO APPLY THESE PRINCIPLES IN PRACTICE.

PROFESSIONAL CONDUCT AND INTEGRITY
