SYMBOLISM AND VISUAL METAPHORS

THIS TECHNIQUE DRAWS ATTENTION TO THE ACTORS INVOLVED IN THE POLITICAL PROCESS, WHETHER THEY ARE LAWMAKERS, JUDGES, OR BUREAUCRATS, HIGHLIGHTING THEIR ACTIONS IN RELATION TO LIMITED GOVERNMENT PRINCIPLES.

IRONY AND SATIRE

IRONY IS OFTEN EMPLOYED TO EXPOSE CONTRADICTIONS OR HYPOCRISY IN GOVERNMENT BEHAVIOR, ESPECIALLY WHEN OFFICIALS CLAIM TO SUPPORT LIMITED GOVERNMENT BUT ACT CONTRARY TO THOSE IDEALS. SATIRE SHARPENS THE CRITIQUE BY RIDICULING EXCESSIVE OR UNCHECKED GOVERNMENT POWER, MAKING THE MESSAGE MORE COMPELLING AND MEMORABLE.

HISTORICAL DEVELOPMENT AND NOTABLE EXAMPLES
