## OVERVIEW OF HANDICAP PARKING AT LINCOLN FINANCIAL FIELD

LINCOLN FINANCIAL FIELD PROVIDES DEDICATED HANDICAP PARKING TO ENSURE THAT GUESTS WITH DISABILITIES HAVE EQUITABLE ACCESS TO THE STADIUM. THE VENUE COMPLIES WITH THE AMERICANS WITH DISABILITIES ACT (ADA) STANDARDS, OFFERING ACCESSIBLE PARKING SPACES THAT ARE STRATEGICALLY LOCATED FOR EASE OF ACCESS TO THE STADIUM ENTRANCES. HANDICAP PARKING IS DESIGNED TO ACCOMMODATE A VARIETY OF MOBILITY NEEDS, INCLUDING THOSE USING WHEELCHAIRS, SCOOTERS, OR OTHER MOBILITY AIDS. THE PARKING AREAS PROVIDE WIDER SPACES, CURB CUTS, AND SMOOTH PATHS LEADING DIRECTLY TO ACCESSIBLE ENTRANCES. LINCOLN FINANCIAL FIELD PRIORITIZES SAFETY AND CONVENIENCE, MAKING HANDICAP PARKING AN INTEGRAL PART OF THE OVERALL ACCESSIBILITY PLAN FOR VISITORS.

## IMPORTANCE OF HANDICAP PARKING ACCESSIBILITY

THIS COMMITMENT TO ACCESSIBILITY REFLECTS LINCOLN FINANCIAL FIELD'S DEDICATION TO INCLUSIVITY AND COMPLIANCE WITH FEDERAL REGULATIONS.

## COMPLIANCE WITH ADA STANDARDS

LINCOLN FINANCIAL FIELD ADHERES STRICTLY TO ADA GUIDELINES, WHICH MANDATE A MINIMUM NUMBER OF ACCESSIBLE PARKING SPACES RELATIVE TO THE TOTAL NUMBER OF PARKING SPOTS AVAILABLE. THESE SPACES ARE DESIGNED WITH SPECIFIC DIMENSIONS, SIGNAGE, AND SURFACE CONDITIONS TO MEET REGULATORY REQUIREMENTS. THE VENUE CONTINUALLY EVALUATES AND UPDATES ITS HANDICAP PARKING FACILITIES TO ENSURE COMPLIANCE AND IMPROVE THE OVERALL GUEST EXPERIENCE. THIS ONGOING EFFORT INCLUDES STAFF TRAINING ON ADA COMPLIANCE AND CUSTOMER SERVICE FOR GUESTS WITH DISABILITIES.

# ACCESSIBLE PARKING LOCATIONS AND FEATURES

HANDICAP PARKING AT LINCOLN FINANCIAL FIELD IS AVAILABLE IN MULTIPLE DESIGNATED AREAS THROUGHOUT THE PARKING COMPLEX. THESE LOCATIONS ARE CHOSEN FOR THEIR PROXIMITY TO ACCESSIBLE ENTRANCES, ELEVATORS, AND RAMPS, FACILITATING EASY ENTRY TO THE STADIUM. THE ACCESSIBLE PARKING LOTS ARE CLEARLY MARKED AND MONITORED TO ENSURE AVAILABILITY FOR AUTHORIZED VEHICLES ONLY. THE FOLLOWING ARE KEY FEATURES AND LOCATIONS OF HANDICAP PARKING AT LINCOLN FINANCIAL FIELD.

## MAIN ACCESSIBLE PARKING AREAS

THE PRIMARY HANDICAP PARKING ZONES AT LINCOLN FINANCIAL FIELD ARE LOCATED NEAR THE FOLLOWING GATES AND SECTIONS:

- GATE A PARKING LOT – CLOSEST TO THE MAIN STADIUM ENTRANCE AND ELEVATORS
- GATE C PARKING LOT – PROVIDES ACCESS TO THE NORTH SIDE OF THE STADIUM
- TAILGATE LOTS WITH ACCESSIBLE SPACES – FOR PRE-GAME EVENT CONVENIENCE

EACH OF THESE LOTS INCLUDES RESERVED SPACES FOR VEHICLES DISPLAYING VALID HANDICAP PERMITS. THE LOTS ARE PAVED, WELL-LIT, AND EQUIPPED WITH CURB CUTS AND RAMPS TO ENABLE SMOOTH ACCESS TO THE STADIUM CONCOURSES.

## FEATURES OF HANDICAP PARKING SPACES

ACCESSIBLE PARKING SPACES AT LINCOLN FINANCIAL FIELD INCLUDE:

- EXTRA-WIDE SPACES TO ACCOMMODATE WHEELCHAIR LIFTS AND VEHICLE RAMPS
- CLEAR, VISIBLE SIGNAGE INDICATING RESERVED HANDICAP PARKING
- PROXIMITY TO ACCESSIBLE ROUTES AND ENTRANCES TO MINIMIZE TRAVEL DISTANCE
- FLAT, SLIP-RESISTANT SURFACES FOR SAFETY
- DESIGNATED DROP-OFF ZONES NEAR ACCESSIBLE ENTRANCES FOR ADDITIONAL CONVENIENCE

## PERMIT REQUIREMENTS AND HOW TO OBTAIN THEM

ACCESS TO HANDICAP PARKING AT LINCOLN FINANCIAL FIELD REQUIRES A VALID DISABILITY PARKING PERMIT. THIS ENSURES THAT ONLY INDIVIDUALS WITH VERIFIED MOBILITY IMPAIRMENTS USE THE ACCESSIBLE PARKING SPACES. UNDERSTANDING THE PERMIT REQUIREMENTS AND HOW TO OBTAIN THEM IS ESSENTIAL FOR VISITORS PLANNING THEIR TRIP TO THE STADIUM.

## VALID PERMITS ACCEPTED

THE STADIUM ACCEPTS THE FOLLOWING PERMITS FOR HANDICAP PARKING:

- STATE-ISSUED DISABILITY PARKING PLACARDS OR LICENSE PLATES
- TEMPORARY OR PERMANENT HANDICAP PARKING PERMITS ISSUED BY AUTHORIZED AGENCIES

VISITORS MUST DISPLAY THEIR PERMITS PROMINENTLY IN THEIR VEHICLES WHEN PARKED IN HANDICAP-DESIGNATED AREAS. THIS ENABLES PARKING ENFORCEMENT PERSONNEL TO VERIFY ELIGIBILITY AND ENSURE PROPER USE OF ACCESSIBLE SPACES.

## OBTAINING A DISABILITY PARKING PERMIT

INDIVIDUALS WHO REQUIRE A DISABILITY PARKING PERMIT SHOULD APPLY THROUGH THEIR STATE'S DEPARTMENT OF MOTOR VEHICLES (DMV) OR EQUIVALENT AGENCY. THE APPLICATION PROCESS TYPICALLY REQUIRES A MEDICAL CERTIFICATION OF DISABILITY FROM A LICENSED HEALTHCARE PROVIDER. PERMITS COME IN TWO FORMS: PERMANENT PLACARDS THAT MAY BE VALID FOR SEVERAL YEARS AND TEMPORARY PERMITS FOR SHORT-TERM USE. IT IS ADVISABLE THAT VISITORS SECURE THEIR PERMITS WELL IN ADVANCE OF THEIR VISIT TO LINCOLN FINANCIAL FIELD TO AVOID ANY PARKING COMPLICATIONS ON EVENT DAY.

## ARRIVAL AND DEPARTURE PROCEDURES FOR HANDICAP PARKING

LINCOLN FINANCIAL FIELD HAS ESTABLISHED CLEAR PROCEDURES TO FACILITATE SMOOTH ARRIVAL AND DEPARTURE FOR GUESTS USING HANDICAP PARKING. THESE PROCEDURES HELP MANAGE TRAFFIC FLOW, REDUCE WAIT TIMES, AND ENSURE SAFETY FOR ALL ATTENDEES.

## RECOMMENDED ARRIVAL TIMES

GUESTS USING HANDICAP PARKING ARE ENCOURAGED TO ARRIVE EARLY DUE TO THE HIGH VOLUME OF TRAFFIC ON EVENT DAYS. EARLY ARRIVAL ALLOWS SUFFICIENT TIME TO NAVIGATE TO ACCESSIBLE PARKING AREAS AND LOCATE SEATING WITHOUT RUSHING. EVENT STAFF ARE ON HAND TO ASSIST WITH DIRECTIONS AND PROVIDE SUPPORT IF NEEDED.

## TRAFFIC FLOW AND ACCESS POINTS

DESIGNATED ROUTES LEAD TO HANDICAP PARKING LOTS, WHICH ARE CLEARLY MARKED WITH SIGNAGE. TRAFFIC CONTROL PERSONNEL ASSIST IN GUIDING VEHICLES TO AVAILABLE ACCESSIBLE SPACES. UPON DEPARTURE, GUESTS ARE DIRECTED TO SPECIFIC EXIT ROUTES TO MINIMIZE CONGESTION AND FACILITATE A QUICK AND SAFE EXIT FROM THE PARKING AREA.

## ASSISTANCE SERVICES

STAFF MEMBERS AND VOLUNTEERS ARE TRAINED TO ASSIST GUESTS WITH DISABILITIES AS THEY ENTER AND EXIT THE PARKING AREA. THIS ASSISTANCE MAY INCLUDE HELP WITH NAVIGATION, LOADING AND UNLOADING MOBILITY DEVICES, AND PROVIDING INFORMATION ABOUT SHUTTLE SERVICES IF AVAILABLE.

## ADDITIONAL ACCESSIBILITY SERVICES AND AMENITIES

BEYOND HANDICAP PARKING, LINCOLN FINANCIAL FIELD OFFERS A RANGE OF SERVICES AND AMENITIES DESIGNED TO ENHANCE THE EXPERIENCE FOR GUESTS WITH DISABILITIES. THESE FEATURES ALIGN WITH THE VENUE'S COMMITMENT TO PROVIDING AN INCLUSIVE ENVIRONMENT.

## ACCESSIBLE SEATING AND VIEWING AREAS

THE STADIUM INCLUDES NUMEROUS ACCESSIBLE SEATING LOCATIONS EQUIPPED WITH COMPANION SEATING. THESE AREAS PROVIDE EXCELLENT SIGHTLINES AND ACCOMMODATE WHEELCHAIRS AND OTHER MOBILITY DEVICES. STADIUM USHERS ARE AVAILABLE TO ASSIST WITH SEATING ARRANGEMENTS AND ANY SPECIAL NEEDS DURING THE EVENT.

## ACCESSIBLE RESTROOMS AND CONCESSIONS

ACCESSIBLE RESTROOMS ARE LOCATED THROUGHOUT THE STADIUM, FEATURING WIDER STALLS, GRAB BARS, AND LOWER SINKS. CONCESSION STANDS ALSO PROVIDE ACCESSIBLE COUNTERS TO ENSURE EASE OF USE FOR ALL GUESTS.

## SERVICE ANIMAL POLICIES

LINCOLN FINANCIAL FIELD PERMITS SERVICE ANIMALS THROUGHOUT THE STADIUM, INCLUDING HANDICAP PARKING AREAS, TO ASSIST GUESTS WITH DISABILITIES. STAFF ARE TRAINED TO ACCOMMODATE SERVICE ANIMALS AND PROVIDE GUIDANCE ON DESIGNATED RELIEF AREAS.

## TIPS FOR VISITORS USING HANDICAP PARKING

PLANNING AHEAD AND UNDERSTANDING THE AVAILABLE SERVICES CAN SIGNIFICANTLY IMPROVE THE EXPERIENCE FOR VISITORS USING HANDICAP PARKING AT LINCOLN FINANCIAL FIELD. THE FOLLOWING TIPS HELP ENSURE A SMOOTH VISIT.

1. CONFIRM YOUR DISABILITY PARKING PERMIT IS VALID AND DISPLAYED PROMINENTLY IN YOUR VEHICLE.
2. ARRIVE EARLY TO AVOID HEAVY TRAFFIC AND SECURE ACCESSIBLE PARKING SPACES.
3. REVIEW THE STADIUM MAP IN ADVANCE TO FAMILIARIZE YOURSELF WITH ACCESSIBLE PARKING LOCATIONS AND ENTRANCES.
4. USE THE ASSISTANCE SERVICES OFFERED BY STADIUM STAFF IF NEEDED.
5. PLAN YOUR DEPARTURE TIME TO AVOID PEAK EXIT CONGESTION.
6. INFORM YOUR GROUP ABOUT ACCESSIBILITY ARRANGEMENTS TO COORDINATE ARRIVAL AND SEATING EFFECTIVELY.
7. KEEP THE STADIUM'S CUSTOMER SERVICE CONTACT INFORMATION HANDY IN CASE YOU NEED ASSISTANCE BEFORE OR DURING YOUR VISIT.

## FREQUENTLY ASKED QUESTIONS

### WHAT ARE THE LOCATIONS OF HANDICAP PARKING AT LINCOLN FINANCIAL FIELD?

HANDICAP PARKING AT LINCOLN FINANCIAL FIELD IS LOCATED IN DESIGNATED ACCESSIBLE PARKING AREAS CLOSE TO THE STADIUM ENTRANCES, INCLUDING LOTS A, C, AND E, ENSURING CONVENIENT ACCESS FOR GUESTS WITH DISABILITIES.

### HOW CAN I RESERVE HANDICAP PARKING AT LINCOLN FINANCIAL FIELD?

HANDICAP PARKING CANNOT TYPICALLY BE RESERVED IN ADVANCE AT LINCOLN FINANCIAL FIELD. IT IS AVAILABLE ON A FIRST-COME, FIRST-SERVED BASIS FOR GUESTS DISPLAYING A VALID HANDICAP PARKING PERMIT.

### IS THERE A FEE FOR HANDICAP PARKING AT LINCOLN FINANCIAL FIELD?

YES, THERE ARE DESIGNATED DROP-OFF ZONES NEAR THE ENTRANCES OF LINCOLN FINANCIAL FIELD FOR GUESTS WITH DISABILITIES TO BE DROPPED OFF BEFORE PARKING.

## IS ACCESSIBLE PARKING AVAILABLE FOR ALL EVENTS AT LINCOLN FINANCIAL FIELD?
