LOUISIANA LAWS AND REGULATIONS

ONCE YOU PASS THE EXAM, YOU WILL NEED TO SUBMIT THE FOLLOWING TO OBTAIN YOUR TITLE INSURANCE LICENSE:

1. **APPLICATION FOR LICENSE:** COMPLETE THE APPLICATION AS REQUIRED BY THE LOUISIANA DEPARTMENT OF INSURANCE.
2. **BACKGROUND CHECK:** UNDERGO A CRIMINAL BACKGROUND CHECK AND PROVIDE ANY NECESSARY DOCUMENTATION.
3. **PAYMENT OF FEES:** PAY THE REQUIRED LICENSING FEES.
