- SKEPTICAL DOCUMENTARIES: OTHERS HAVE PRODUCED DOCUMENTARIES AIMED AT DEBUNKING THEIR CLAIMS, EMPHASIZING THE NEED FOR CRITICAL THINKING AND SCRUTINY OF EXTRAORDINARY ASSERTIONS.

IMPLICATIONS OF THEIR CLAIMS

THEY CONTINUE TO ENGAGE IN ACTIVISM, RAISING AWARENESS ABOUT THEIR EXPERIENCES AND ADVOCATING FOR VICTIMS OF TRAUMA AND ABUSE, OFTEN THROUGH SOCIAL MEDIA AND PUBLIC FORUMS.
