LICENSING REQUIREMENTS FOR MARYLAND INSURANCE ADJUSTERS

ELIGIBILITY CRITERIA

1. AGE: YOU MUST BE AT LEAST 18 YEARS OLD.
2. RESIDENCY: YOU MUST BE A RESIDENT OF MARYLAND OR A NON-RESIDENT WHO HOLDS AN ADJUSTER LICENSE IN YOUR HOME STATE.
3. BACKGROUND CHECK: YOU MUST PASS A CRIMINAL BACKGROUND CHECK. CERTAIN CRIMINAL CONVICTIONS MAY DISQUALIFY YOU FROM OBTAINING A LICENSE.
4. PRE-LICENSING EDUCATION: YOU MUST COMPLETE A STATE-APPROVED PRE-LICENSING EDUCATION COURSE.

PRE-LICENSING EDUCATION REQUIREMENTS

MARYLAND REQUIRES PROSPECTIVE ADJUSTERS TO COMPLETE A SPECIFIC NUMBER OF HOURS IN PRE-LICENSING EDUCATION. THE APPROVED COURSES TYPICALLY COVER THE FOLLOWING TOPICS:

- INSURANCE PRINCIPLES AND PRACTICES
- TYPES OF INSURANCE POLICIES
- LEGAL ASPECTS OF INSURANCE
- CLAIMS HANDLING PROCESSES
- ETHICS AND PROFESSIONAL CONDUCT

4. UNDERGO BACKGROUND CHECKS

AS PART OF THE APPLICATION PROCESS, YOU WILL BE REQUIRED TO UNDERGO A CRIMINAL BACKGROUND CHECK. THIS ENSURES

THAT ALL LICENSED ADJUSTERS ADHERE TO ETHICAL AND LEGAL STANDARDS.

5. RECEIVE YOUR LICENSE

UPON APPROVAL OF YOUR APPLICATION AND SUCCESSFUL COMPLETION OF ALL REQUIREMENTS, YOU WILL RECEIVE YOUR MARYLAND INSURANCE ADJUSTER LICENSE. CONGRATULATIONS! YOU ARE NOW READY TO EMBARK ON YOUR CAREER AS AN INSURANCE ADJUSTER.

CONTINUING EDUCATION AND LICENSE RENEWAL
