TYPES OF MATRICES

MATRICES COME IN VARIOUS FORMS, EACH SERVING DIFFERENT PURPOSES:

1. ROW MATRIX: A MATRIX WITH ONLY ONE ROW.
2. COLUMN MATRIX: A MATRIX WITH ONLY ONE COLUMN.
3. SQUARE MATRIX: A MATRIX WITH THE SAME NUMBER OF ROWS AND COLUMNS.
4. ZERO MATRIX: A MATRIX IN WHICH ALL ELEMENTS ARE ZERO.
5. IDENTITY MATRIX: A SQUARE MATRIX WITH ONES ON THE DIAGONAL AND ZEROS ELSEWHERE.

MATRIX OPERATIONS

SEVERAL OPERATIONS CAN BE PERFORMED ON MATRICES, INCLUDING:

- ADDITION: TWO MATRICES OF THE SAME DIMENSIONS CAN BE ADDED BY ADDING THEIR CORRESPONDING ELEMENTS.
- SUBTRACTION: SIMILAR TO ADDITION, TWO MATRICES OF THE SAME DIMENSIONS CAN BE SUBTRACTED ELEMENT-WISE.
- MULTIPLICATION: THE PRODUCT OF TWO MATRICES $\begin{pmatrix} A \end{pmatrix}$ AND $\begin{pmatrix} B \end{pmatrix}$ IS DEFINED ONLY WHEN THE NUMBER OF COLUMNS IN $\begin{pmatrix} A \end{pmatrix}$ MATCHES THE NUMBER OF ROWS IN $\begin{pmatrix} B \end{pmatrix}$. THE RESULTING MATRIX HAS DIMENSIONS EQUAL TO THE NUMBER OF ROWS IN $\begin{pmatrix} A \end{pmatrix}$ AND THE NUMBER OF COLUMNS IN $\begin{pmatrix} B \end{pmatrix}$.
- TRANSPOSE: THE TRANSPOSE OF A MATRIX $\begin{pmatrix} A \end{pmatrix}$ IS OBTAINED BY SWAPPING ITS ROWS AND COLUMNS, DENOTED AS $\begin{pmatrix} A^T \end{pmatrix}$.

LINEAR TRANSFORMATIONS EXPLAINED

A LINEAR TRANSFORMATION IS A MAPPING BETWEEN TWO VECTOR SPACES THAT PRESERVES THE OPERATIONS OF VECTOR ADDITION AND SCALAR MULTIPLICATION. IF $(T: V \rightarrow W)$ IS A LINEAR TRANSFORMATION FROM VECTOR SPACE (V) TO VECTOR SPACE (W) , THEN FOR ANY VECTORS $(\mathbf{u}, \mathbf{v} \in V)$ AND ANY SCALAR (c) , THE FOLLOWING PROPERTIES MUST HOLD:

1. ADDITIVITY: $(T(\mathbf{u} + \mathbf{v}) = T(\mathbf{u}) + T(\mathbf{v}))$
2. HOMOGENEITY: $(T(c\mathbf{u}) = cT(\mathbf{u}))$

REPRESENTING LINEAR TRANSFORMATIONS WITH MATRICES

EVERY LINEAR TRANSFORMATION CAN BE REPRESENTED BY A MATRIX. IF $(T: \mathbb{R}^n \rightarrow \mathbb{R}^m)$ IS A LINEAR TRANSFORMATION, THERE EXISTS A MATRIX (A) OF SIZE $(m \times n)$ SUCH THAT:

$$(T(\mathbf{x}) = A\mathbf{x})$$

FOR ANY VECTOR $(\mathbf{x} \in \mathbb{R}^n)$. THIS RELATIONSHIP ALLOWS FOR THE USE OF MATRIX OPERATIONS TO ANALYZE AND COMPUTE THE EFFECTS OF LINEAR TRANSFORMATIONS.

EXAMPLES OF LINEAR TRANSFORMATIONS

SOME COMMON TYPES OF LINEAR TRANSFORMATIONS INCLUDE:

1. SCALING: A TRANSFORMATION THAT MULTIPLIES EACH COMPONENT OF A VECTOR BY A CONSTANT FACTOR.
