- PROGRESS NOTES DOCUMENTING THE PATIENT'S RESPONSE TO TREATMENT
- ANY CHANGES IN THE PATIENT'S CONDITION

THIS INFORMATION IS CRITICAL FOR CONTINUITY OF CARE AND EFFECTIVE FOLLOW-UP.

5. LABORATORY AND DIAGNOSTIC TEST RESULTS

DOCUMENTATION OF LABORATORY AND DIAGNOSTIC TEST RESULTS IS ESSENTIAL FOR:

- TRACKING THE PATIENT'S HEALTH STATUS
- MAKING INFORMED CLINICAL DECISIONS
- COMMUNICATING WITH OTHER HEALTHCARE PROVIDERS

MAs MUST ENSURE THAT THESE RESULTS ARE ACCURATELY RECORDED AND EASILY ACCESSIBLE.

COMMON CHALLENGES IN CHARTING PRACTICE
