3. CERTIFIED MEDICATION AIDE (CMA) CERTIFICATION: THIS CERTIFICATION IS SPECIFICALLY DESIGNED FOR UNLICENSED PERSONNEL IN LONG-TERM CARE SETTINGS, FOCUSING ON MEDICATION ADMINISTRATION.

APPROVED TRAINING PROGRAMS

LOUISIANA OFFERS A VARIETY OF APPROVED TRAINING PROGRAMS FOR MEDICATION ADMINISTRATION. THESE PROGRAMS CAN BE FOUND IN:

- DOCUMENTATION PRACTICES: PROPERLY RECORDING MEDICATION ADMINISTRATION IN PATIENT CHARTS TO MAINTAIN ACCURATE HEALTH RECORDS.

HANDS-ON PRACTICE

PRACTICAL EXPERIENCE IS ESSENTIAL FOR MASTERING MEDICATION ADMINISTRATION. TRAINING PROGRAMS TYPICALLY INCLUDE:
