- FAIR HOUSING LAWS

CANDIDATES ARE GIVEN 3.5 HOURS TO COMPLETE THE MICHIGAN REAL ESTATE EXAM.

WHAT IDENTIFICATION DO I NEED TO BRING TO THE MICHIGAN REAL ESTATE EXAM?

CANDIDATES MUST BRING A VALID GOVERNMENT-ISSUED PHOTO ID, SUCH AS A DRIVER'S LICENSE OR PASSPORT, TO THE EXAM.

IS THERE A STUDY GUIDE AVAILABLE FOR THE MICHIGAN REAL ESTATE EXAM?
