- DISTRACTED DRIVING: AVOID USING YOUR PHONE OR ENGAGING IN ANY ACTIVITIES THAT MAY DISTRACT YOU FROM DRIVING.
- WEATHER CONDITIONS: ADJUST YOUR DRIVING BEHAVIOR ACCORDING TO WEATHER CONDITIONS, SUCH AS RAIN, SNOW, OR FOG.

TAKING THE PERMIT TEST

WHAT TO EXPECT ON TEST DAY

- **PASSING THE TEST:** IF YOU PASS, YOU WILL RECEIVE YOUR LEARNER'S PERMIT, ALLOWING YOU TO START PRACTICING DRIVING WITH A LICENSED ADULT.
- **RETAKING THE TEST:** IF YOU DO NOT PASS, DON'T BE DISCOURAGED. REVIEW THE AREAS WHERE YOU STRUGGLED, AND SCHEDULE A RETEST AS SOON AS POSSIBLE.
