MONITORING PROGRESS AND PLAN ADAPTATION

CASE EXAMPLE 2: IDENTITY RECONSTRUCTION AFTER TRAUMA

IN CASES OF TRAUMA, THE TREATMENT PLAN FOCUSES ON SEPARATING THE TRAUMA FROM THE CLIENT'S IDENTITY.
