STATES USING THE PSI EXAM

EXAM STRUCTURE AND CONTENT

THIS SECTION CAN INCLUDE QUESTIONS ON STATE AGENCY LAW, LICENSING RULES, DISCLOSURES, FAIR HOUSING LAWS, AND OTHER REGULATIONS UNIQUE TO THE JURISDICTION. CANDIDATES MUST STUDY THEIR STATE'S STATUTES AND ADMINISTRATIVE RULES THOROUGHLY TO PASS THIS PART OF THE EXAM.

QUESTION FORMAT AND SCORING

THE EXAM QUESTIONS ARE USUALLY MULTIPLE-CHOICE, WITH A SET NUMBER OF QUESTIONS FOR EACH SECTION. CANDIDATES MUST ACHIEVE A PASSING SCORE, WHICH VARIES BY STATE BUT GENERALLY RANGES FROM 70% TO 75%. THE EXAM IS TIMED, AND CANDIDATES SHOULD MANAGE THEIR TIME EFFECTIVELY TO ANSWER ALL QUESTIONS.
