ELIGIBILITY REQUIREMENTS

FIREARM TRAINING COURSE

NORTH CAROLINA REQUIRES ALL CONCEALED CARRY APPLICANTS TO COMPLETE A STATE-APPROVED FIREARM TRAINING COURSE. THIS COURSE COVERS FIREARM SAFETY, HANDLING, STORAGE, AND APPLICABLE LAWS. THE CONCEALED CARRY TEST IS TYPICALLY ADMINISTERED AT THE CONCLUSION OF THIS COURSE TO ASSESS THE APPLICANT'S KNOWLEDGE AND READINESS.

COMMON NC CONCEALED CARRY TEST QUESTIONS

LEGAL USE OF DEADLY FORCE

PLACES WHERE CONCEALED CARRY IS PROHIBITED

ANSWER: YOU SHOULD IMMEDIATELY INFORM THE OFFICER THAT YOU ARE CARRYING A CONCEALED HANDGUN AND FOLLOW THEIR INSTRUCTIONS CAREFULLY.

4. **QUESTION:** IS IT LEGAL TO CARRY A CONCEALED HANDGUN IN A BAR OR ESTABLISHMENT THAT SERVES ALCOHOL?

ANSWER: IT IS GENERALLY PROHIBITED TO CARRY A CONCEALED HANDGUN IN ESTABLISHMENTS WHERE THE PRIMARY PURPOSE IS SERVING ALCOHOL FOR CONSUMPTION ON THE PREMISES.

5. **QUESTION:** HOW OFTEN MUST YOU RENEW YOUR NORTH CAROLINA CONCEALED CARRY PERMIT?

ANSWER: THE PERMIT MUST BE RENEWED EVERY FIVE YEARS.

TEST FORMAT AND SCORING
