NC MEDICAID POLICY MANUAL SERVES AS THE COMPREHENSIVE GUIDE THAT OUTLINES THE RULES, PROCEDURES, AND REGULATIONS GOVERNING MEDICAID SERVICES IN NORTH CAROLINA. OVERVIEW OF THE NC MEDICAID POLICY MANUAL

THE NC MEDICAID POLICY MANUAL IS AN AUTHORITATIVE RESOURCE COMPILED BY THE NORTH CAROLINA DEPARTMENT OF HEALTH AND HUMAN SERVICES (NCDHHS). IT CONSOLIDATES FEDERAL AND STATE MEDICAID POLICIES INTO A SINGLE REFERENCE THAT DEFINES OPERATIONAL STANDARDS, PROGRAM REQUIREMENTS, AND BENEFICIARY PROTECTIONS. THE MANUAL IS STRUCTURED TO PROVIDE CLEAR GUIDANCE FOR ADMINISTERING MEDICAID IN COMPLIANCE WITH THE CENTERS FOR MEDICARE & MEDICAID SERVICES (CMS) REGULATIONS AND NORTH CAROLINA STATE LAWS.

THIS MANUAL IS DESIGNED TO BE ACCESSIBLE TO A VARIETY OF USERS, INCLUDING MEDICAID PROVIDERS, CASE MANAGERS, FISCAL AGENTS, AND POLICY ANALYSTS. IT INCLUDES DETAILED EXPLANATIONS OF ELIGIBILITY DETERMINATION, BENEFIT COVERAGE, PROVIDER ENROLLMENT PROCESSES, BILLING PROTOCOLS, AND COMPLIANCE MONITORING.

PURPOSE AND SCOPE

THE PRIMARY PURPOSE OF THE NC MEDICAID POLICY MANUAL IS TO ENSURE CONSISTENT APPLICATION OF MEDICAID POLICIES ACROSS THE STATE. IT COVERS ALL MEDICAID PROGRAMS ADMINISTERED IN NORTH CAROLINA, SUCH AS TRADITIONAL MEDICAID, MEDICAID MANAGED CARE, AND SPECIALIZED PROGRAMS FOR VULNERABLE POPULATIONS. ELIGIBILITY AND ENROLLMENT POLICIES

ELIGIBILITY AND ENROLLMENT CRITERIA ARE FOUNDATIONAL COMPONENTS DESCRIBED EXTENSIVELY IN THE NC MEDICAID POLICY MANUAL. THIS SECTION OUTLINES WHO QUALIFIES FOR MEDICAID SERVICES BASED ON INCOME, HOUSEHOLD COMPOSITION, DISABILITY STATUS, AGE, AND OTHER FACTORS. IT ALSO EXPLAINS THE ENROLLMENT PROCESS AND DOCUMENTATION REQUIREMENTS.

ELIGIBILITY CATEGORIES

NORTH CAROLINA MEDICAID ELIGIBILITY IS DIVIDED INTO SEVERAL CATEGORIES, INCLUDING BUT NOT LIMITED TO:

- CHILDREN UNDER THE AGE OF 19
- PREGNANT WOMEN
- PARENTS AND CARETAKER RELATIVES
- INDIVIDUALS AGED 65 OR OLDER
- PERSONS WITH DISABILITIES
- MEDICALLY NEEDY INDIVIDUALS

THE MANUAL DETAILS INCOME LIMITS, RESOURCE TESTS, AND SPECIFIC ELIGIBILITY RULES FOR EACH CATEGORY TO ENSURE ACCURATE DETERMINATIONS.

APPLICATION PROCESS

THE MANUAL SPECIFIES THE APPLICATION PROCEDURES, INCLUDING REQUIRED DOCUMENTATION SUCH AS PROOF OF INCOME, CITIZENSHIP, RESIDENCY, AND MEDICAL NECESSITY. IT ALSO DESCRIBES VERIFICATION PROCESSES AND TIMELINES FOR ELIGIBILITY DETERMINATION AND REDETERMINATION.

COVERED SERVICES AND BENEFITS

MEDICAL SERVICES

COVERED MEDICAL SERVICES TYPICALLY INCLUDE:

- INPATIENT AND OUTPATIENT HOSPITAL CARE
- PHYSICIAN AND SPECIALIST VISITS
- DIAGNOSTIC SERVICES SUCH AS LAB TESTS AND IMAGING
- PRESCRIPTION DRUGS
- PREVENTIVE CARE AND IMMUNIZATIONS

- MENTAL HEALTH AND SUBSTANCE ABUSE TREATMENT

THE MANUAL ALSO SPECIFIES PRIOR AUTHORIZATION REQUIREMENTS AND SERVICE EXCLUSIONS.

LONG-TERM CARE AND SUPPORT SERVICES

NORTH CAROLINA MEDICAID COVERS LONG-TERM CARE OPTIONS INCLUDING NURSING HOME CARE, HOME AND COMMUNITY-BASED SERVICES (HCBS), AND DURABLE MEDICAL EQUIPMENT. THE MANUAL OUTLINES ELIGIBILITY FOR THESE SERVICES AS WELL AS SERVICE DELIVERY MODELS AND PROVIDER QUALIFICATIONS.

PROVIDER PARTICIPATION AND RESPONSIBILITIES

HEALTHCARE PROVIDERS MUST FOLLOW THE GUIDELINES ESTABLISHED IN THE NC MEDICAID POLICY MANUAL TO PARTICIPATE IN THE PROGRAM. THIS SECTION EXPLAINS PROVIDER ENROLLMENT PROCEDURES, CREDENTIALING STANDARDS, AND ONGOING RESPONSIBILITIES TO MAINTAIN GOOD STANDING WITHIN THE MEDICAID NETWORK.

PROVIDER ENROLLMENT

PROVIDERS APPLY FOR PARTICIPATION BY SUBMITTING REQUIRED CREDENTIALS AND DOCUMENTATION TO THE MEDICAID AGENCY. THE MANUAL DESCRIBES THE APPLICATION PROCESS, APPROVAL CRITERIA, AND REQUIRED AGREEMENTS THAT PROVIDERS MUST SIGN BEFORE RENDERING SERVICES.

PROVIDER RESPONSIBILITIES

PROVIDERS ARE RESPONSIBLE FOR:

- ADHERING TO MEDICAID POLICIES AND BILLING RULES
- MAINTAINING ACCURATE MEDICAL RECORDS
- FURNISHING MEDICALLY NECESSARY SERVICES
- COMPLYING WITH AUDITS AND QUALITY ASSURANCE REVIEWS
- TIMELY SUBMISSION OF CLAIMS AND DOCUMENTATION

CLAIMS PROCESSING AND BILLING PROCEDURES

PROPER CLAIMS SUBMISSION AND BILLING ARE CRITICAL TO MEDICAID PROGRAM INTEGRITY AND PROVIDER REIMBURSEMENT. THE NC MEDICAID POLICY MANUAL OFFERS DETAILED INSTRUCTIONS REGARDING CLAIMS FORMATS, REQUIRED DOCUMENTATION, AND PAYMENT PROCESSES.

CLAIMS SUBMISSION

PROGRAM INTEGRITY AND AUDITS

MEDICAID CONDUCTS REGULAR AUDITS TO VERIFY SERVICE DELIVERY, BILLING ACCURACY, AND PROVIDER QUALIFICATIONS. THE MANUAL DETAILS AUDIT TRIGGERS, DOCUMENTATION REQUESTS, AND CORRECTIVE ACTION PLANS FOR IDENTIFIED DEFICIENCIES.

APPEALS PROCESS

PROVIDERS AND BENEFICIARIES HAVE THE RIGHT TO APPEAL ADVERSE DECISIONS, SUCH AS CLAIM DENIALS OR ELIGIBILITY DETERMINATIONS. THE MANUAL EXPLAINS THE STEPS FOR FILING APPEALS, TIMELINES, AND HEARING PROCEDURES TO ENSURE DUE PROCESS.
