UNDERSTANDING THE NORTH CAROLINA REAL ESTATE LICENSING PROCESS

PRE-LICENSING EDUCATION REQUIREMENTS

NORTH CAROLINA MANDATES COMPLETION OF 75 HOURS OF APPROVED PRE-LICENSING EDUCATION BEFORE CANDIDATES ARE ELIGIBLE TO TAKE THE LICENSING EXAM.
