- QUIZ EACH OTHER ON KEY CONCEPTS
- DISCUSS CHALLENGING TOPICS

4. PRACTICE WITH FLASHCARDS

CREATING FLASHCARDS CAN BE A HELPFUL WAY TO MEMORIZE IMPORTANT TERMS AND CONCEPTS. FOCUS ON:

- KEY TERMS RELATED TO WATER CHEMISTRY
- SAFETY REGULATIONS AND PROCEDURES
- EMERGENCY RESPONSE PROTOCOLS
