- WARNING SIGNS: THESE SIGNS ALERT YOU TO POTENTIAL HAZARDS ON THE ROAD (E.G., CURVE AHEAD, PEDESTRIAN CROSSING).
- GUIDE SIGNS: THESE SIGNS PROVIDE DIRECTIONAL AND MILEAGE INFORMATION (E.G., HIGHWAY EXITS, CITY NAMES).

SAFE DRIVING PRACTICES

EXPECT QUESTIONS THAT FOCUS ON MAINTAINING SAFETY WHILE DRIVING. KEY CONCEPTS INCLUDE:

- SAFE FOLLOWING DISTANCES
- THE IMPORTANCE OF SEAT BELTS
- HOW TO HANDLE ADVERSE WEATHER CONDITIONS
- TECHNIQUES FOR DEFENSIVE DRIVING

PREPARATION TIPS FOR THE NEVADA DMV WRITTEN TEST

STUDY THE NEVADA DRIVER'S HANDBOOK

THE NEVADA DRIVER'S HANDBOOK IS YOUR PRIMARY RESOURCE FOR STUDYING. IT COVERS ALL THE NECESSARY TOPICS AND INCLUDES EXPLANATIONS OF TRAFFIC LAWS, SAFE DRIVING PRACTICES, AND INFORMATION ABOUT ROAD SIGNS. YOU CAN FIND THE HANDBOOK ONLINE ON THE NEVADA DMV WEBSITE OR IN PHYSICAL COPIES AT DMV OFFICES.

USE FLASHCARDS

ATTEND A DRIVER EDUCATION COURSE

IF YOU FEEL YOU NEED ADDITIONAL HELP, CONSIDER ENROLLING IN A DRIVER EDUCATION COURSE. THESE COURSES OFTEN COVER THE MATERIAL NEEDED FOR THE WRITTEN TEST AND PROVIDE ADDITIONAL RESOURCES FOR PRACTICAL DRIVING SKILLS.

STAY CALM AND CONFIDENT

ON THE DAY OF THE TEST, TRY TO STAY CALM AND CONFIDENT. TAKE YOUR TIME WHEN ANSWERING QUESTIONS, AND IF YOU'RE UNSURE ABOUT AN ANSWER, MAKE YOUR BEST GUESS BASED ON WHAT YOU HAVE STUDIED.
