1. NATIONAL SECTION: THIS PART COVERS GENERAL REAL ESTATE CONCEPTS THAT ARE APPLICABLE ACROSS THE UNITED STATES, INCLUDING:

- PROPERTY OWNERSHIP AND LAND USE CONTROLS
- REAL ESTATE FINANCING
- AGENCY RELATIONSHIPS
- ROLES OF THE REAL ESTATE PROFESSIONAL
- CONTRACTS AND NEGOTIATIONS

2. STATE-SPECIFIC SECTION: THIS PART FOCUSES ON NEVADA'S REAL ESTATE LAWS AND REGULATIONS, INCLUDING:

- LICENSING REQUIREMENTS
- REAL ESTATE DISCLOSURES
- FAIR HOUSING LAWS
- NEVADA LANDLORD-TENANT LAWS
- COMMISSION REGULATIONS

THE EXAM TYPICALLY CONSISTS OF 120 QUESTIONS, WITH 80 QUESTIONS FROM THE NATIONAL SECTION AND 40 FROM THE STATE-SPECIFIC SECTION. CANDIDATES MUST SCORE AT LEAST 75% TO PASS.

TYPES OF QUESTIONS

- C) LIFE ESTATE

- D) COMMON AREA

REAL ESTATE FINANCING

FINANCING QUESTIONS OFTEN FOCUS ON VARIOUS LOAN TYPES, INTEREST RATES, AND THE MORTGAGE PROCESS. SAMPLE QUESTIONS CAN INCLUDE:

- WHICH OF THE FOLLOWING IS A CHARACTERISTIC OF A CONVENTIONAL LOAN?
- WHAT IS THE PRIMARY PURPOSE OF THE TRUTH IN LENDING ACT?

AGENCY RELATIONSHIPS

THESE QUESTIONS ASSESS YOUR UNDERSTANDING OF THE FIDUCIARY RESPONSIBILITIES AGENTS HAVE TOWARD THEIR CLIENTS. AN EXAMPLE QUESTION MIGHT BE:

- WHAT IS THE PRIMARY DUTY OF A REAL ESTATE AGENT TO THEIR CLIENT?

CONTRACTS AND NEGOTIATIONS

YOU MAY ENCOUNTER QUESTIONS ABOUT THE ELEMENTS OF A VALID CONTRACT AND THE NEGOTIATION PROCESS:

- WHICH OF THE FOLLOWING IS NOT A REQUIREMENT FOR A CONTRACT TO BE VALID?
- WHAT IS THE PURPOSE OF AN EARNEST MONEY DEPOSIT?

PREPARATION STRATEGIES

PREPARING FOR THE NEVADA REAL ESTATE EXAM REQUIRES A STRATEGIC APPROACH. HERE ARE SOME EFFECTIVE STRATEGIES TO HELP YOU SUCCEED.
