2. CLASS B CDL: THIS LICENSE PERMITS THE OPERATION OF A SINGLE VEHICLE WITH A GVWR OF 26,001 POUNDS OR MORE, AND IT MAY ALSO TOW A VEHICLE WEIGHING UP TO 10,000 POUNDS.
3. CLASS C CDL: THIS CLASS IS FOR DRIVERS WHO OPERATE VEHICLES DESIGNED TO TRANSPORT 16 OR MORE PASSENGERS (INCLUDING THE DRIVER) OR HAZARDOUS MATERIALS IN AMOUNTS REQUIRING PLACARDING.

KEY TOPICS COVERED IN THE NEW MEXICO CDL MANUAL
