

NFPA 70E TRAINING CLASSES

NFPA 70E TRAINING CLASSES ARE ESSENTIAL FOR ENSURING THE SAFETY OF WORKERS IN ENVIRONMENTS WHERE ELECTRICAL HAZARDS ARE PRESENT. THE IMPORTANCE OF NFPA 70E TRAINING

5. EMERGENCY RESPONSE PROCEDURES

TRAINING ALSO COVERS WHAT TO DO IN CASE OF AN ELECTRICAL INCIDENT, INCLUDING:

- EMERGENCY SHUTDOWN PROCEDURES
- FIRST AID FOR ELECTRICAL INJURIES
- REPORTING INCIDENTS

BENEFITS OF NFPA 70E TRAINING CLASSES

5. LOOK FOR EXPERIENCED INSTRUCTORS

INSTRUCTORS SHOULD HAVE EXTENSIVE EXPERIENCE IN ELECTRICAL SAFETY AND A STRONG UNDERSTANDING OF NFPA 70E. LOOK FOR TRAINERS WHO HAVE PRACTICAL FIELD EXPERIENCE AND TEACHING CREDENTIALS.
