COMMON TRAFFIC VIOLATIONS IN NJ TITLE 39

- **RUNNING A RED LIGHT:** FAILING TO STOP AT A RED TRAFFIC SIGNAL CAN RESULT IN FINES AND POINTS ON YOUR DRIVING RECORD.
- **FAILURE TO WEAR A SEATBELT:** NEW JERSEY MANDATES SEATBELT USE; VIOLATIONS CAN LEAD TO FINES.

PENALTIES FOR VIOLATIONS

THE PENALTIES FOR TRAFFIC VIOLATIONS IN NEW JERSEY VARY DEPENDING ON THE SEVERITY OF THE OFFENSE. COMMON PENALTIES INCLUDE:

1. **FINES:** MONETARY PENALTIES THAT VARY BASED ON THE VIOLATION.
2. **POINTS:** ACCUMULATING POINTS ON YOUR DRIVING RECORD CAN LEAD TO INCREASED INSURANCE PREMIUMS AND POTENTIAL LICENSE SUSPENSION.

UNDERSTANDING POINTS SYSTEM IN NJ

NEW JERSEY EMPLOYS A POINTS SYSTEM TO TRACK TRAFFIC VIOLATIONS. POINTS ARE ADDED TO A DRIVER'S RECORD FOR CERTAIN OFFENSES, AND ACCUMULATING TOO MANY POINTS CAN LEAD TO PENALTIES, INCLUDING LICENSE SUSPENSION.

POINT ACCUMULATION AND CONSEQUENCES

THE FOLLOWING OUTLINES HOW POINTS ARE ASSIGNED FOR VARIOUS VIOLATIONS:

- SPEEDING 1-14 MPH OVER THE LIMIT: 2 POINTS
- SPEEDING 15-29 MPH OVER THE LIMIT: 4 POINTS
- DRIVING UNDER THE INFLUENCE (DUI): 8 POINTS
- RECKLESS DRIVING: 5 POINTS
- FAILING TO STOP FOR A SCHOOL BUS: 5 POINTS

IF A DRIVER ACCUMULATES 12 OR MORE POINTS WITHIN A THREE-YEAR PERIOD, THEY MAY FACE LICENSE SUSPENSION. HOWEVER, DRIVERS CAN ATTEND A STATE-APPROVED DEFENSIVE DRIVING COURSE TO REDUCE POINTS ON THEIR RECORD.

STEPS TO TAKE AFTER RECEIVING A TICKET

RECEIVING A TRAFFIC TICKET CAN BE A STRESSFUL EXPERIENCE, BUT KNOWING THE RIGHT STEPS TO TAKE CAN HELP MITIGATE THE CONSEQUENCES. HERE'S WHAT TO DO:

1. **READ THE TICKET THOROUGHLY:** UNDERSTAND THE VIOLATION, PENALTIES, AND DUE DATES FOR PAYMENT OR COURT APPEARANCE.
2. **DECIDE WHETHER TO PAY OR CONTEST:** CONSIDER IF THE VIOLATION IS VALID AND WHETHER YOU HAVE GROUNDS TO CONTEST IT.
3. **GATHER EVIDENCE:** IF CONTESTING, COLLECT EVIDENCE SUCH AS PHOTOGRAPHS, WITNESS STATEMENTS, OR DASHCAM FOOTAGE.
4. **CONSIDER LEGAL ASSISTANCE:** HIRING AN ATTORNEY MAY BE BENEFICIAL, ESPECIALLY FOR SERIOUS OFFENSES.
5. **ATTEND COURT IF NECESSARY:** IF YOU CONTEST THE TICKET, PREPARE TO PRESENT YOUR CASE IN COURT.

YES, YOU CAN CONTEST A TRAFFIC TICKET IN COURT. IT'S ADVISABLE TO GATHER EVIDENCE AND CONSIDER LEGAL REPRESENTATION IF YOU PLAN TO APPEAL.
