IF A NOTARY SUSPECTS THAT A SIGNER IS BEING COERCED, THEY SHOULD REFUSE TO NOTARIZE THE DOCUMENT TO UPHOLD THEIR ETHICAL DUTY TO ENSURE THAT THE SIGNER IS ACTING VOLUNTARILY.

CAN A NOTARY PUBLIC IN NORTH CAROLINA NOTARIZE DOCUMENTS FOR FAMILY MEMBERS?
