THE ACCREDITATION PROCESS

IMPORTANCE OF ABA ACCREDITATION

ATTENDING AN ABA-APPROVED LAW SCHOOL IS CRUCIAL FOR SEVERAL REASONS:

YES, IT IS POSSIBLE TO TRANSFER FROM A NON-ABA-APPROVED LAW SCHOOL TO AN ABA-APPROVED LAW SCHOOL, BUT THE ACCEPTANCE OF TRANSFER CREDITS AND ADMISSION POLICIES CAN VARY BY INSTITUTION.
