- MATERIAL HANDLING
- SAFE PRACTICES FOR LIFTING, MOVING, AND STORING MATERIALS TO AVOID INJURIES.
- WORKPLACE VIOLENCE
- RECOGNIZING THE SIGNS OF WORKPLACE VIOLENCE AND STRATEGIES FOR PREVENTION.
- HEALTH HAZARDS
- UNDERSTANDING CHEMICAL SAFETY, INCLUDING THE GLOBALLY HARMONIZED SYSTEM (GHS) OF CLASSIFICATION AND LABELING OF CHEMICALS.

IMPORTANCE OF PASSING THE FINAL EXAM

PASSING THE FINAL EXAM IS CRUCIAL FOR SEVERAL REASONS:
