UNDERSTANDING BLOODBORNE PATHOGENS

BLOODBORNE PATHOGENS ARE MICROORGANISMS PRESENT IN HUMAN BLOOD THAT CAN CAUSE DISEASE IN HUMANS. UNDERSTANDING THESE PATHOGENS IS CRUCIAL FOR EMPLOYEES WHO MAY BE EXPOSED TO BLOOD OR OTHER POTENTIALLY INFECTIOUS MATERIALS (OPIM) DURING THEIR WORK. THE PRIMARY PATHOGENS OF CONCERN INCLUDE:

- HIV (HUMAN IMMUNODEFICIENCY VIRUS): A VIRUS THAT ATTACKS THE IMMUNE SYSTEM AND CAN LEAD TO AIDS (ACQUIRED IMMUNODEFICIENCY SYNDROME).
- HEPATITIS B VIRUS (HBV): A VIRUS THAT AFFECTS THE LIVER AND CAN LEAD TO CHRONIC LIVER DISEASE AND LIVER CANCER.
- HEPATITIS C VIRUS (HCV): ANOTHER VIRUS THAT INFECTS THE LIVER AND CAN CAUSE CHRONIC LIVER DISEASE.

TRANSMISSION OF BLOODBORNE PATHOGENS

BLOODBORNE PATHOGENS CAN BE TRANSMITTED THROUGH:

1. DIRECT CONTACT: WHEN INFECTED BLOOD OR OPIM COMES INTO DIRECT CONTACT WITH BROKEN SKIN OR MUCOUS MEMBRANES.
2. NEEDLESTICK INJURIES: ACCIDENTAL PUNCTURES FROM NEEDLES OR OTHER SHARP INSTRUMENTS THAT HAVE BEEN IN CONTACT WITH INFECTED MATERIALS.
3. IMPROPER DISPOSAL: FAILURE TO PROPERLY DISPOSE OF CONTAMINATED MATERIALS CAN LEAD TO EXPOSURE FOR OTHERS.

OSHA'S BLOODBORNE PATHOGENS STANDARD

OSHA'S BLOODBORNE PATHOGENS STANDARD (29 CFR 1910.1030) ESTABLISHES REQUIREMENTS FOR EMPLOYERS TO PROTECT EMPLOYEES FROM THE RISKS ASSOCIATED WITH BLOODBORNE PATHOGENS. THE STANDARD MANDATES:

- EXPOSURE CONTROL PLAN: EMPLOYERS MUST DEVELOP AND IMPLEMENT A WRITTEN PLAN OUTLINING HOW THEY WILL MINIMIZE EMPLOYEE EXPOSURE TO BLOODBORNE PATHOGENS.
- TRAINING: EMPLOYERS MUST PROVIDE TRAINING FOR ALL EMPLOYEES WITH OCCUPATIONAL EXPOSURE TO BLOODBORNE PATHOGENS.
- VACCINATIONS: EMPLOYERS ARE REQUIRED TO OFFER THE HEPATITIS B VACCINE TO EMPLOYEES AT RISK OF EXPOSURE.
- PERSONAL PROTECTIVE EQUIPMENT (PPE): EMPLOYERS MUST PROVIDE APPROPRIATE PPE, SUCH AS GLOVES, GOWNS, AND FACE SHIELDS, TO EMPLOYEES.

- PROCEDURES FOR SAFELY CLEANING UP SPILLS AND DISPOSING OF CONTAMINATED MATERIALS.
- IMPORTANCE OF REPORTING ANY EXPOSURES OR INCIDENTS IMMEDIATELY.

5. POST-EXPOSURE PROTOCOLS

THE TRAINING VIDEO EXPLAINS WHAT STEPS TO TAKE IF AN EXPOSURE INCIDENT OCCURS, INCLUDING:

- IMMEDIATE WASHING OF THE EXPOSED AREA WITH SOAP AND WATER.

WHAT TYPES OF PERSONAL PROTECTIVE EQUIPMENT (PPE) ARE RECOMMENDED IN THE TRAINING?

RECOMMENDED TYPES OF PERSONAL PROTECTIVE EQUIPMENT (PPE) INCLUDE GLOVES, MASKS, GOGGLES, FACE SHIELDS, AND GOWNS TO PROTECT EMPLOYEES FROM POTENTIAL EXPOSURE TO BLOODBORNE PATHOGENS.

WHAT SHOULD AN EMPLOYEE DO IF THEY EXPERIENCE AN EXPOSURE INCIDENT?

IF AN EMPLOYEE EXPERIENCES AN EXPOSURE INCIDENT, THEY SHOULD IMMEDIATELY WASH THE AREA WITH SOAP AND WATER, REPORT THE INCIDENT TO THEIR SUPERVISOR, AND SEEK MEDICAL EVALUATION AND FOLLOW-UP AS PER THE COMPANY'S EXPOSURE CONTROL PLAN.

HOW CAN ORGANIZATIONS ENSURE THEIR EMPLOYEES UNDERSTAND THE TRAINING CONTENT?

ORGANIZATIONS CAN ENSURE EMPLOYEES UNDERSTAND THE TRAINING CONTENT BY INCORPORATING INTERACTIVE ELEMENTS, CONDUCTING QUIZZES, PROVIDING OPPORTUNITIES FOR QUESTIONS, AND OFFERING HANDS-ON PRACTICE WITH PPE AND PROCEDURES.
