OVERVIEW OF HEALTHCARE INTEROPERABILITY STANDARDS HIQA

3. **SEMANTIC INTEROPERABILITY:** THIS IS THE HIGHEST LEVEL OF INTEROPERABILITY, ENABLING SYSTEMS TO EXCHANGE DATA WITH A SHARED UNDERSTANDING OF THE MEANING OF THE INFORMATION. THIS IS CRUCIAL FOR EFFECTIVE CLINICAL DECISION-MAKING.

IMPORTANCE OF INTEROPERABILITY STANDARDS

INTEROPERABILITY STANDARDS ARE VITAL FOR SEVERAL REASONS:

HIQA AND ITS ROLE IN INTEROPERABILITY STANDARDS

KEY RESPONSIBILITIES OF HIQA

4. **PROVIDING GUIDANCE:** THE AUTHORITY OFFERS GUIDANCE AND SUPPORT TO HEALTHCARE ORGANIZATIONS IN IMPLEMENTING INTEROPERABILITY STANDARDS EFFECTIVELY.

HIQA'S INTEROPERABILITY FRAMEWORK

HIQA HAS DEVELOPED A COMPREHENSIVE INTEROPERABILITY FRAMEWORK THAT OUTLINES THE NECESSARY COMPONENTS FOR EFFECTIVE HEALTH INFORMATION EXCHANGE. THIS FRAMEWORK INCLUDES THE FOLLOWING KEY ELEMENTS:

- **DATA STANDARDS:** ESTABLISHING COMMON STANDARDS FOR DATA FORMATS, TERMINOLOGIES, AND CODING SYSTEMS TO ENSURE CONSISTENCY IN DATA EXCHANGE.

CHALLENGES IN ACHIEVING INTEROPERABILITY

LACK OF STANDARDIZATION
