3. PERFORMANCE TEST:

- ESSAY QUESTIONS REQUIRE A THOROUGH UNDERSTANDING OF LEGAL PRINCIPLES AND THE ABILITY TO ARTICULATE THEM CLEARLY.
- THESE QUESTIONS OFTEN INCLUDE A FACT PATTERN FOLLOWED BY SPECIFIC PROMPTS.
- **EFFECTIVE STRATEGIES INCLUDE:**
- **IRAC METHOD:** USE THE ISSUE, RULE, APPLICATION, AND CONCLUSION FRAMEWORK TO STRUCTURE YOUR ESSAYS.
- **PRACTICE WRITING:** REGULARLY PRACTICE WRITING ESSAYS UNDER TIMED CONDITIONS TO BUILD SPEED AND CLARITY.
- **REVIEW SAMPLE ANSWERS:** STUDY HIGH-SCORING ESSAYS TO UNDERSTAND WHAT EXAMINERS ARE LOOKING FOR.

PERFORMANCE TEST QUESTIONS

- THE PERFORMANCE TEST CHALLENGES CANDIDATES TO DEMONSTRATE PRACTICAL LAWYERING SKILLS.
- CANDIDATES ARE TYPICALLY PROVIDED WITH A CASE FILE AND MUST COMPLETE A TASK, SUCH AS DRAFTING A LEGAL DOCUMENT.

- INCORPORATE TIMED PRACTICE EXAMS INTO YOUR STUDY SCHEDULE TO BUILD ENDURANCE AND CONFIDENCE.

OVERLOOKING PENNSYLVANIA LAW

- SOME CANDIDATES FOCUS HEAVILY ON MBE SUBJECTS WHILE NEGLECTING PENNSYLVANIA-SPECIFIC LAW.
- ENSURE TO ALLOCATE ENOUGH TIME TO REVIEW THE STATE-SPECIFIC MATERIALS AND PRACTICE ESSAY QUESTIONS THAT INCORPORATE PENNSYLVANIA LAW.

IGNORING SELF-CARE

- THE MONTHS LEADING UP TO THE EXAM CAN BE STRESSFUL, BUT NEGLECTING SELF-CARE CAN IMPACT PERFORMANCE.
- MAINTAIN A BALANCED LIFESTYLE BY INCORPORATING REGULAR EXERCISE, ADEQUATE SLEEP, AND HEALTHY EATING HABITS.
