4. JOIN STUDY GROUPS

COLLABORATE WITH FELLOW CANDIDATES IN STUDY GROUPS. SHARING KNOWLEDGE AND DISCUSSING COMPLEX TOPICS CAN ENHANCE UNDERSTANDING AND RETENTION.

5. TAKE CARE OF YOUR WELL-BEING

WHILE STUDYING IS CRUCIAL, MAINTAINING A HEALTHY BALANCE IS EQUALLY IMPORTANT. ENSURE YOU GET ENOUGH REST, EXERCISE, AND TAKE BREAKS TO RECHARGE.
