## UNDERSTANDING PARKINSON'S LAW

PARKINSON'S LAW IS A TIME MANAGEMENT PRINCIPLE FIRST ARTICULATED BY CYRIL NORTHCOTE PARKINSON IN 1955. THE LAW STATES THAT "WORK EXPANDS SO AS TO FILL THE TIME AVAILABLE FOR ITS COMPLETION." ## HISTORICAL BACKGROUND AND DEFINITION

CYRIL PARKINSON INITIALLY OBSERVED THIS LAW IN THE CONTEXT OF ADMINISTRATIVE GROWTH WITHIN THE BRITISH CIVIL SERVICE. HE NOTED THAT THE NUMBER OF EMPLOYEES TENDED TO INCREASE REGARDLESS OF THE ACTUAL WORKLOAD, AS WORK WOULD EXPAND TO OCCUPY THE AVAILABLE TIME.
