WHAT IS PART 107?

WHO NEEDS TO COMPLY WITH PART 107?

RECREATIONAL FLYERS OPERATING STRICTLY FOR FUN ARE EXEMPT BUT MUST STILL FOLLOW BASIC FAA GUIDELINES. OBTAINING THE REMOTE PILOT CERTIFICATE IS MANDATORY FOR COMMERCIAL OPERATIONS AND DEMONSTRATES COMPETENCY IN DRONE FLIGHT AND REGULATORY KNOWLEDGE.

FAA REGULATIONS AND DRONE OPERATING RULES

THIS SECTION DELVES INTO THE SPECIFIC FAA REGULATIONS THAT DRONE PILOTS MUST UNDERSTAND AND FOLLOW. OPERATIONAL LIMITATIONS

REMOTE PILOT RESPONSIBILITIES

THE REMOTE PILOT IN COMMAND MUST CONDUCT PRE-FLIGHT RISK ASSESSMENTS, ENSURE THE DRONE IS IN SAFE CONDITION, AND COMPLY WITH ALL APPLICABLE REGULATIONS DURING OPERATION. UNDERSTANDING AIRSPACE AND FLIGHT RESTRICTIONS

SOME AREAS HAVE PERMANENT OR TEMPORARY FLIGHT RESTRICTIONS THAT PROHIBIT OR LIMIT DRONE OPERATIONS. THESE INCLUDE AREAS NEAR AIRPORTS, STADIUMS, EMERGENCY RESPONSE SCENES, AND SPECIAL EVENTS. THE PART 107 DRONE STUDY GUIDE INSTRUCTS PILOTS ON HOW TO IDENTIFY AND RESPECT THESE RESTRICTIONS TO AVOID PENALTIES.

WEATHER FACTORS IMPACTING DRONE FLIGHT

USING WEATHER REPORTS AND FORECASTS
