WEATHER KNOWLEDGE

EMERGENCY PROCEDURES AND SAFETY

REMOTE PILOTS MUST BE PREPARED FOR IN-FLIGHT EMERGENCIES. THE EXAM INCLUDES SCENARIOS THAT REQUIRE KNOWLEDGE OF EMERGENCY PROTOCOLS, COMMUNICATION PROCEDURES, AND RISK MITIGATION STRATEGIES.

RADIO COMMUNICATION AND AIRPORT OPERATIONS

WHILE DRONES DO NOT TYPICALLY REQUIRE DIRECT RADIO COMMUNICATION WITH AIR TRAFFIC CONTROL, UNDERSTANDING BASIC COMMUNICATION PRINCIPLES AND AIRPORT OPERATIONS IS IMPORTANT. THIS KNOWLEDGE HELPS IN AVOIDING CONFLICTS WITH MANNED AIRCRAFT AND MAINTAINING SITUATIONAL AWARENESS.
