

# POINT PLEASANT ASBESTOS LEGAL QUESTION

**POINT PLEASANT ASBESTOS LEGAL QUESTION:** AS CONCERNS ABOUT ASBESTOS EXPOSURE CONTINUE TO GROW, MANY RESIDENTS AND WORKERS IN POINT PLEASANT, NEW JERSEY, FIND THEMSELVES GRAPPLING WITH LEGAL QUESTIONS REGARDING THIS HAZARDOUS MATERIAL. ASBESTOS, A NATURALLY OCCURRING MINERAL ONCE POPULAR FOR ITS FIRE-RESISTANT PROPERTIES, HAS BEEN LINKED TO SERIOUS HEALTH CONDITIONS, INCLUDING MESOTHELIOMA, LUNG CANCER, AND ASBESTOSIS. ## POTENTIAL SOURCES OF ASBESTOS EXPOSURE IN POINT PLEASANT

RESIDENTS AND WORKERS IN POINT PLEASANT MAY HAVE BEEN EXPOSED TO ASBESTOS IN VARIOUS SETTINGS, INCLUDING:

### 1. INDUSTRIAL SITES

MANY INDUSTRIAL FACILITIES IN POINT PLEASANT MAY HAVE USED ASBESTOS IN MANUFACTURING PROCESSES. WORKERS INVOLVED IN THESE INDUSTRIES MAY HAVE INHALED ASBESTOS FIBERS.

### 3. SHIPYARDS AND MARITIME ACTIVITIES

GIVEN NEW JERSEY'S MARITIME HISTORY, SHIPYARDS AND RELATED INDUSTRIES MAY HAVE USED ASBESTOS FOR INSULATION AND FIREPROOFING. WORKERS IN THESE ENVIRONMENTS MAY BE AT RISK FOR ASBESTOS EXPOSURE.

### 4. HOUSEHOLD PRODUCTS

SOME HOUSEHOLD PRODUCTS MANUFACTURED BEFORE THE 1980S CONTAINED ASBESTOS. HOMEOWNERS MAY UNKNOWNLY

USE OR DISTURB THESE MATERIALS DURING DIY PROJECTS.

## LEGAL RIGHTS FOR ASBESTOS EXPOSURE VICTIMS

IF YOU OR A LOVED ONE HAS BEEN DIAGNOSED WITH AN ASBESTOS-RELATED ILLNESS, IT IS ESSENTIAL TO UNDERSTAND YOUR LEGAL RIGHTS. VICTIMS OF ASBESTOS EXPOSURE OFTEN HAVE SEVERAL AVENUES FOR SEEKING COMPENSATION:

### 1. PERSONAL INJURY CLAIMS

VICTIMS CAN FILE PERSONAL INJURY LAWSUITS AGAINST THE COMPANIES RESPONSIBLE FOR THEIR ASBESTOS EXPOSURE. THESE CLAIMS MAY SEEK DAMAGES FOR MEDICAL EXPENSES, LOST WAGES, PAIN AND SUFFERING, AND OTHER RELATED COSTS.

### 2. WRONGFUL DEATH CLAIMS

IF AN INDIVIDUAL DIES FROM AN ASBESTOS-RELATED DISEASE, THEIR FAMILY MAY FILE A WRONGFUL DEATH CLAIM AGAINST THE RESPONSIBLE PARTIES. THIS CLAIM CAN PROVIDE FINANCIAL COMPENSATION FOR FUNERAL EXPENSES, LOSS OF COMPANIONSHIP, AND OTHER DAMAGES.

### 3. ASBESTOS TRUST FUNDS

MANY COMPANIES THAT MANUFACTURED ASBESTOS PRODUCTS ESTABLISHED TRUST FUNDS TO COMPENSATE VICTIMS. THESE FUNDS ARE DESIGNED TO HELP INDIVIDUALS WHO MAY HAVE BEEN EXPOSED TO THEIR PRODUCTS, EVEN IF THE COMPANIES HAVE SINCE DECLARED BANKRUPTCY.

### 4. WORKERS' COMPENSATION

IF THE EXPOSURE OCCURRED IN A WORKPLACE SETTING, VICTIMS MAY BE ELIGIBLE FOR WORKERS' COMPENSATION BENEFITS. THIS CAN COVER MEDICAL BILLS AND LOST WAGES WITHOUT NEEDING TO PROVE NEGLIGENCE.

## THE PROCESS OF FILING AN ASBESTOS CLAIM IN POINT PLEASANT

NAVIGATING THE LEGAL SYSTEM CAN BE DAUNTING, ESPECIALLY WHEN DEALING WITH HEALTH ISSUES RELATED TO ASBESTOS EXPOSURE. HERE'S A STEP-BY-STEP GUIDE TO HELP INDIVIDUALS IN POINT PLEASANT UNDERSTAND THE CLAIMS PROCESS:

### 1. STATUTE OF LIMITATIONS

### 2. EVIDENCE OF NEGLIGENCE

TO SUCCEED IN A PERSONAL INJURY CLAIM, YOU MUST DEMONSTRATE THAT THE RESPONSIBLE PARTY ACTED NEGLIGENTLY. THIS MAY INCLUDE PROVING THAT THEY KNEW ABOUT THE DANGERS OF ASBESTOS BUT FAILED TO WARN OR PROTECT INDIVIDUALS FROM EXPOSURE.

### 3. THE ROLE OF EXPERT TESTIMONY

EXPERT WITNESSES MAY BE NECESSARY TO ESTABLISH THE LINK BETWEEN YOUR ASBESTOS EXPOSURE AND YOUR ILLNESS. MEDICAL EXPERTS CAN PROVIDE TESTIMONY REGARDING YOUR DIAGNOSIS AND PROGNOSIS, WHILE INDUSTRIAL HYGIENISTS MAY DISCUSS EXPOSURE LEVELS AND SAFETY STANDARDS.

### 4. SETTLEMENT VS. TRIAL

MANY ASBESTOS CASES SETTLE BEFORE REACHING TRIAL. YOUR ATTORNEY WILL NEGOTIATE ON YOUR BEHALF, BUT IT'S ESSENTIAL TO UNDERSTAND YOUR OPTIONS AND BE PREPARED FOR EITHER OUTCOME.

## FREQUENTLY ASKED QUESTIONS

### WHAT IS ASBESTOS AND WHY IS IT A CONCERN IN POINT PLEASANT?

ASBESTOS IS A NATURALLY OCCURRING MINERAL THAT WAS WIDELY USED IN CONSTRUCTION AND INSULATION DUE TO ITS HEAT RESISTANCE. ### WHAT STEPS SHOULD A POINT PLEASANT RESIDENT TAKE IF THEY BELIEVE THEY HAVE BEEN EXPOSED TO ASBESTOS?

IF A RESIDENT BELIEVES THEY HAVE BEEN EXPOSED TO ASBESTOS, THEY SHOULD SEEK MEDICAL EVALUATION TO ASSESS THEIR HEALTH AND CONSIDER CONSULTING WITH A LEGAL PROFESSIONAL WHO SPECIALIZES IN ASBESTOS LITIGATION TO UNDERSTAND THEIR RIGHTS AND OPTIONS.

### ARE THERE SPECIFIC LAWS IN NEW JERSEY THAT GOVERN ASBESTOS EXPOSURE AND LITIGATION?

YES, NEW JERSEY HAS SPECIFIC LAWS AND REGULATIONS REGARDING ASBESTOS EXPOSURE, INCLUDING THE ASBESTOS HAZARD EMERGENCY RESPONSE ACT (AHERA) AND VARIOUS STATE-LEVEL STATUTES THAT GOVERN HOW ASBESTOS MUST BE HANDLED AND THE RIGHTS OF INDIVIDUALS EXPOSED TO ASBESTOS.

### HOW LONG DOES ONE HAVE TO FILE A LEGAL CLAIM FOR ASBESTOS EXPOSURE IN POINT PLEASANT?

IN NEW JERSEY, THE STATUTE OF LIMITATIONS FOR FILING A PERSONAL INJURY CLAIM RELATED TO ASBESTOS EXPOSURE IS GENERALLY TWO YEARS FROM THE DATE THE ILLNESS IS DIAGNOSED OR FROM WHEN THE VICTIM SHOULD HAVE REASONABLY

KNOWN ABOUT THE EXPOSURE AND ITS EFFECTS.
