SURGICAL PROCEDURE CODING

SURGICAL CODING REQUIRES PRECISE IDENTIFICATION OF THE EXACT PROCEDURE PERFORMED, THE APPROACH USED, AND ANY MODIFIERS APPLICABLE. CODERS DIFFERENTIATE BETWEEN PRIMARY AND SECONDARY PROCEDURES, BUNDLED SERVICES, AND SEPARATE PROCEDURES TO ENSURE PROPER BILLING.

EMERGENCY DEPARTMENT CODING

EMERGENCY CODING INVOLVES RAPID ASSESSMENT OF PATIENT CONDITION AND ASSIGNMENT OF E/M CODES BASED ON PRESENTING PROBLEMS AND SERVICES PROVIDED. CODERS MUST BE ADEPT AT INTERPRETING DOCUMENTATION THAT MAY BE BRIEF OR INCOMPLETE.
