3. PERFORMANCE TESTS

PERFORMANCE TESTS SIMULATE REAL-LIFE LEGAL TASKS, SUCH AS DRAFTING A MEMO OR CLIENT LETTER. THEY EVALUATE A CANDIDATE'S PRACTICAL SKILLS IN A TIME-CONSTRAINED ENVIRONMENT. CANDIDATES ARE PROVIDED WITH A FILE CONTAINING MATERIALS RELEVANT TO THE TASK, WHICH THEY MUST ANALYZE AND USE TO PRODUCE A WRITTEN DOCUMENT.

JOINING A STUDY GROUP CAN PROVIDE CANDIDATES WITH DIVERSE PERSPECTIVES ON COMPLEX LEGAL CONCEPTS. DISCUSSING PREVIOUS EXAM QUESTIONS CAN ALSO ENHANCE UNDERSTANDING AND RETENTION OF MATERIAL.

CONSIDER WORKING WITH MENTORS OR PEERS WHO CAN PROVIDE CONSTRUCTIVE CRITICISM.
