- INVESTMENT ACCOUNTS (STOCKS, BONDS, MUTUAL FUNDS)
- RETIREMENT ACCOUNTS (401(k), IRA)
- PERSONAL PROPERTY:
 - JEWELRY
 - ARTWORK
 - COLLECTIBLES
 - HOUSEHOLD ITEMS
- BUSINESS INTERESTS:
 - OWNERSHIP STAKES IN BUSINESSES
 - PARTNERSHIPS

3. LIABILITIES

IT IS EQUALLY IMPORTANT TO ACCOUNT FOR DEBTS AND LIABILITIES. THIS SECTION MIGHT INCLUDE:

- MORTGAGES
- CAR LOANS
- CREDIT CARD DEBTS
- STUDENT LOANS
- ANY OTHER PERSONAL LOANS

4. VALUATION OF ASSETS AND LIABILITIES

NEXT, YOU SHOULD PROVIDE AN ESTIMATED VALUE FOR EACH ASSET AND LIABILITY. THIS CAN HELP IN DETERMINING THE NET WORTH OF THE MARRIAGE. CONSIDER THE FOLLOWING TIPS FOR VALUATION:

- USE MARKET ESTIMATES OR RECENT APPRAISALS FOR REAL ESTATE AND VEHICLES.
- FOR PERSONAL PROPERTY, CONSIDER FAIR MARKET VALUE OR CURRENT REPLACEMENT COST.
- RETIREMENT ACCOUNTS SHOULD REFLECT THE CURRENT BALANCE.

5. NOTES AND ADDITIONAL INFORMATION

THIS SECTION CAN BE USED FOR ANY ADDITIONAL NOTES OR COMMENTS REGARDING SPECIFIC ASSETS OR DEBTS. FOR INSTANCE, YOU MIGHT WANT TO NOTE THE CONTRIBUTION OF EACH SPOUSE TO SPECIFIC ASSETS OR ANY AGREEMENTS MADE REGARDING CERTAIN ITEMS.

HOW TO USE A PRINTABLE DIVORCE ASSET WORKSHEET EFFECTIVELY
