DEFINITION AND CHARACTERISTICS OF PRIVATE EXPRESS TRUSTS

THESE TRUSTS ARE "PRIVATE" BECAUSE THEY BENEFIT SPECIFIC INDIVIDUALS OR A DEFINED CLASS RATHER THAN THE PUBLIC OR CHARITABLE CAUSES. THE EXPRESS NATURE OF THESE TRUSTS MEANS THAT THE SETTLOR'S INTENTIONS ARE EXPLICITLY COMMUNICATED AND LEGALLY RECOGNIZED.

KEY FEATURES OF PRIVATE EXPRESS TRUSTS

PRIVATE EXPRESS TRUSTS UNDER THE COMMON LAW ARE CHARACTERIZED BY SEVERAL DISTINCT FEATURES THAT DIFFERENTIATE THEM FROM OTHER TRUST FORMS:

ESSENTIAL ELEMENTS FOR THE CREATION OF A PRIVATE EXPRESS TRUST

TO CONSTITUTE A VALID PRIVATE EXPRESS TRUST UNDER THE COMMON LAW, CERTAIN ESSENTIAL ELEMENTS MUST BE SATISFIED. THESE ELEMENTS ENSURE THAT THE TRUST IS LEGALLY RECOGNIZED AND ENFORCEABLE. FAILURE TO MEET THESE REQUIREMENTS CAN RESULT IN THE TRUST BEING DECLARED VOID OR VOIDABLE.

INTENTION OF THE SETTLOR

THE TRUST PROPERTY MUST BE CERTAIN AND IDENTIFIABLE. THE SUBJECT MATTER CAN INCLUDE REAL ESTATE, PERSONAL PROPERTY, MONEY, OR OTHER ASSETS. THE TRUST CANNOT OPERATE IF THE PROPERTY IS VAGUE OR ILL-DEFINED, AS THE TRUSTEE MUST KNOW WHAT ASSETS ARE HELD ON TRUST TO MANAGE THEM APPROPRIATELY.

CERTAINTY OF OBJECTS (BENEFICIARIES)

THE BENEFICIARIES OF A PRIVATE EXPRESS TRUST MUST BE CLEARLY DEFINED OR AT LEAST ASCERTAINABLE. THIS CERTAINTY OF OBJECTS ALLOWS TRUSTEES TO IDENTIFY WHO IS ENTITLED TO BENEFIT AND ENABLES COURTS TO ENFORCE THE TRUST. THE CLASS OF BENEFICIARIES CANNOT BE TOO VAGUE OR BROAD, AS THIS UNDERMINES THE TRUST'S ENFORCEABILITY.

LEGAL FORMALITIES

DEPENDING ON JURISDICTION AND THE NATURE OF TRUST PROPERTY, CERTAIN FORMALITIES MAY BE REQUIRED, SUCH AS WRITING OR REGISTRATION, PARTICULARLY FOR TRUSTS INVOLVING LAND. COMPLIANCE WITH THESE FORMALITIES ENSURES THE TRUST'S VALIDITY AND PROTECTS AGAINST CHALLENGES.
