OVERVIEW OF THE PSI HAWAII REAL ESTATE EXAM

THE PSI HAWAII REAL ESTATE EXAM IS DESIGNED TO ASSESS CANDIDATES' UNDERSTANDING OF ESSENTIAL REAL ESTATE KNOWLEDGE REQUIRED TO PRACTICE IN HAWAII. IT CONSISTS OF TWO PARTS: THE NATIONAL PORTION AND THE STATE-SPECIFIC PORTION. THE NATIONAL SECTION COVERS GENERAL REAL ESTATE PRINCIPLES, PRACTICES, AND FEDERAL LAWS, WHILE THE STATE SECTION FOCUSES ON HAWAII'S REAL ESTATE LAWS, RULES, AND REGULATIONS. THE EXAM IS A REQUIREMENT FOR BOTH REAL ESTATE SALESPERSON AND BROKER LICENSE APPLICANTS. ADMINISTERED BY PSI, A LEADING TESTING SERVICE, THE EXAM ENSURES THAT ALL CANDIDATES MEET THE COMPETENCY STANDARDS MANDATED BY THE HAWAII REAL ESTATE COMMISSION.

PURPOSE AND IMPORTANCE

THE PRIMARY PURPOSE OF THE PSI HAWAII REAL ESTATE EXAM IS TO VERIFY THAT PROSPECTIVE LICENSEES POSSESS THE KNOWLEDGE AND SKILLS NECESSARY TO UPHOLD PROFESSIONAL AND ETHICAL STANDARDS IN REAL ESTATE TRANSACTIONS. PASSING THIS EXAM IS MANDATORY BEFORE OBTAINING A LICENSE AND ENGAGING IN ACTIVITIES SUCH AS LISTING, SELLING, OR MANAGING REAL ESTATE PROPERTIES WITHIN HAWAII. THE EXAM SUPPORTS CONSUMER PROTECTION BY ENSURING THAT LICENSED REAL ESTATE PROFESSIONALS ARE WELL-INFORMED ABOUT RELEVANT LAWS AND PRACTICES.

EXAM STRUCTURE

THE EXAM TYPICALLY COMPRISES TWO SECTIONS: A NATIONAL PORTION WITH APPROXIMATELY 80 QUESTIONS AND A STATE PORTION WITH ABOUT 40 QUESTIONS. THE TOTAL EXAM TIME IS USUALLY AROUND THREE HOURS, ALLOWING CANDIDATES TO DEMONSTRATE THEIR COMPETENCY IN A CONTROLLED ENVIRONMENT. BOTH SECTIONS MUST BE PASSED TO ACHIEVE AN OVERALL PASSING SCORE SET BY THE HAWAII REAL ESTATE COMMISSION.

ELIGIBILITY AND APPLICATION PROCESS

BEFORE REGISTERING FOR THE PSI HAWAII REAL ESTATE EXAM, CANDIDATES MUST FIRST MEET CERTAIN ELIGIBILITY REQUIREMENTS ESTABLISHED BY THE HAWAII DEPARTMENT OF COMMERCE AND CONSUMER AFFAIRS (DCCA). THESE REQUIREMENTS VARY SLIGHTLY DEPENDING ON WHETHER THE CANDIDATE IS APPLYING FOR A SALESPERSON OR BROKER LICENSE.

SALESPERSON ELIGIBILITY

TO QUALIFY FOR THE SALESPERSON EXAM, APPLICANTS MUST:

- BE AT LEAST 18 YEARS OF AGE
- HAVE LEGAL U.S. RESIDENCY OR AUTHORIZATION TO WORK IN THE U.S.
- COMPLETE THE REQUIRED PRE-LICENSING EDUCATION, WHICH INCLUDES 60 HOURS OF APPROVED REAL ESTATE COURSEWORK
- SUBMIT A COMPLETED APPLICATION AND PAY THE ASSOCIATED FEES TO THE DCCA

BROKER ELIGIBILITY

BROKER APPLICANTS MUST MEET MORE STRINGENT CRITERIA, INCLUDING:

- BEING AT LEAST 18 YEARS OF AGE
- POSSESSING AN ACTIVE SALESPERSON LICENSE FOR AT LEAST THREE YEARS OR EQUIVALENT EXPERIENCE
- COMPLETING 80 HOURS OF BROKER PRE-LICENSING EDUCATION APPROVED BY THE HAWAII REAL ESTATE COMMISSION
- SUBMITTING A BROKER LICENSE APPLICATION AND PAYING THE APPLICABLE FEES

APPLICATION SUBMISSION

AFTER FULFILLING EDUCATION AND ELIGIBILITY REQUIREMENTS, CANDIDATES MUST SUBMIT THEIR APPLICATIONS TO THE HAWAII DCCA. ONCE APPROVED, CANDIDATES RECEIVE AUTHORIZATION TO SCHEDULE THE PSI HAWAII REAL ESTATE EXAM.

EXAM CONTENT AND FORMAT

THE PSI HAWAII REAL ESTATE EXAM IS CAREFULLY STRUCTURED TO COVER ALL CRITICAL ASPECTS OF REAL ESTATE PRACTICE. THE EXAM CONTENT REFLECTS CURRENT NATIONAL REAL ESTATE PRINCIPLES ALONGSIDE HAWAII-SPECIFIC LAWS AND REGULATIONS. UNDERSTANDING THE BREAKDOWN OF TOPICS AND QUESTION TYPES IS ESSENTIAL FOR EFFECTIVE PREPARATION.

QUESTION FORMAT AND PASSING SCORE

THE EXAM CONSISTS OF MULTIPLE-CHOICE QUESTIONS, EACH WITH FOUR OPTIONS. CANDIDATES MUST ANSWER QUESTIONS WITHIN THE ALLOTTED TIME, TYPICALLY THREE HOURS TOTAL. THE MINIMUM PASSING SCORE VARIES BUT GENERALLY REQUIRES CORRECTLY ANSWERING AT LEAST 75% OF QUESTIONS ACROSS BOTH SECTIONS COMBINED. BOTH THE NATIONAL AND STATE PORTIONS MUST BE PASSED TO ACHIEVE OVERALL SUCCESS.

REGISTRATION AND SCHEDULING

AFTER ELIGIBILITY APPROVAL, CANDIDATES MUST REGISTER AND SCHEDULE THEIR PSI HAWAII REAL ESTATE EXAM. THE PROCESS IS STREAMLINED TO ACCOMMODATE VARIOUS SCHEDULING NEEDS WHILE MAINTAINING EXAM INTEGRITY.

REGISTRATION PROCESS

REGISTRATION CAN BE COMPLETED ONLINE, BY PHONE, OR MAIL THROUGH PSI'S OFFICIAL CHANNELS. CANDIDATES NEED TO PROVIDE THEIR DCCA AUTHORIZATION NUMBER AND PERSONAL INFORMATION DURING REGISTRATION. PAYMENT OF EXAM FEES IS REQUIRED AT THE TIME OF SCHEDULING.

SCHEDULING OPTIONS

PSI OFFERS MULTIPLE TESTING LOCATIONS THROUGHOUT HAWAII, INCLUDING HONOLULU, MAUI, AND OTHER MAJOR ISLANDS. CANDIDATES CAN SELECT AN EXAM DATE AND TIME THAT FITS THEIR AVAILABILITY. IT IS RECOMMENDED TO SCHEDULE EARLY TO SECURE PREFERRED DATES, ESPECIALLY DURING PEAK LICENSING PERIODS.

FEES AND RESCHEDULING

THE EXAM FEE VARIES DEPENDING ON THE LICENSE TYPE BUT TYPICALLY RANGES FROM \$65 TO \$100. PSI ALLOWS CANDIDATES TO RESCHEDULE OR CANCEL APPOINTMENTS UP TO A CERTAIN TIME BEFORE THE EXAM DATE WITHOUT FORFEITING FEES. LATE CANCELLATIONS OR NO-SHOWS MAY RESULT IN FORFEITURE OF THE EXAM FEE.

PREPARATION AND STUDY RESOURCES

THOROUGH PREPARATION IS KEY TO PASSING THE PSI HAWAII REAL ESTATE EXAM. CANDIDATES SHOULD UTILIZE A COMBINATION OF OFFICIAL STUDY MATERIALS, PRACTICE EXAMS, AND REVIEW COURSES TAILORED TO HAWAII'S LICENSING REQUIREMENTS.

PRE-LICENSING EDUCATION

EXAM DAY PROCEDURES AND TIPS

IDENTIFICATION AND CHECK-IN

CANDIDATES MUST BRING A VALID, GOVERNMENT-ISSUED PHOTO ID THAT MATCHES THE NAME ON THEIR EXAM REGISTRATION. ARRIVING EARLY ALLOWS SUFFICIENT TIME FOR CHECK-IN PROCEDURES, INCLUDING VERIFICATION OF IDENTIFICATION AND TEST RULES BRIEFING.

TESTING ENVIRONMENT

THE EXAM IS COMPUTER-BASED AND ADMINISTERED IN A SECURE TESTING FACILITY. PERSONAL ITEMS SUCH AS PHONES, NOTES, AND CALCULATORS ARE TYPICALLY PROHIBITED. CANDIDATES ARE PROVIDED WITH SCRAP PAPER AND PENCILS FOR CALCULATIONS DURING THE TEST.

DURING THE EXAM

IT IS IMPORTANT TO CAREFULLY READ EACH QUESTION AND ALL ANSWER CHOICES BEFORE SELECTING A RESPONSE. TIME MANAGEMENT IS CRUCIAL; CANDIDATES SHOULD PACE THEMSELVES TO ANSWER ALL QUESTIONS WITHIN THE ALLOTTED TIME. IF UNSURE ABOUT A QUESTION, IT IS ADVISABLE TO SKIP AND RETURN TO IT LATER RATHER THAN SPENDING EXCESSIVE TIME.

AFTER THE EXAM: RESULTS AND LICENSING STEPS

FOLLOWING COMPLETION OF THE PSI HAWAII REAL ESTATE EXAM, CANDIDATES WILL RECEIVE THEIR PRELIMINARY RESULTS IMMEDIATELY OR SHORTLY THEREAFTER, DEPENDING ON THE TESTING CENTER.

EXAM RESULTS

PASSING CANDIDATES RECEIVE A SCORE REPORT, WHICH IS REQUIRED FOR LICENSE APPLICATION SUBMISSION TO THE HAWAII REAL ESTATE COMMISSION. THOSE WHO DO NOT PASS MAY RETAKE THE EXAM AFTER A MANDATORY WAITING PERIOD, SUBJECT TO ADDITIONAL FEES.

LICENSE APPLICATION PROCESS

AFTER PASSING THE EXAM, CANDIDATES MUST COMPLETE THE LICENSING APPLICATION PROCESS, WHICH INCLUDES SUBMITTING FINGERPRINTS FOR A BACKGROUND CHECK AND PAYING LICENSING FEES. ONCE APPROVED, THE CANDIDATE WILL BE ISSUED A REAL ESTATE SALESPERSON OR BROKER LICENSE, ALLOWING THEM TO LEGALLY PRACTICE IN HAWAII.

CONTINUING EDUCATION AND RENEWAL

MAINTAINING AN ACTIVE REAL ESTATE LICENSE IN HAWAII REQUIRES ADHERENCE TO CONTINUING EDUCATION REQUIREMENTS AND TIMELY RENEWAL. LICENSED AGENTS MUST COMPLETE SPECIFIC COURSES EVERY TWO YEARS TO STAY INFORMED ABOUT CHANGES IN LAWS AND INDUSTRY STANDARDS.
