APPLICATION PROCESS AND SCHEDULING

WHAT TO BRING

TESTING CENTER RULES

PSI TESTING CENTERS MAINTAIN STRICT REGULATIONS, INCLUDING:

- NO ELECTRONIC DEVICES OR COMMUNICATION TOOLS ALLOWED
- SECURITY CHECKS UPON ENTRY
- TIME LIMITS ENFORCED RIGOROUSLY
- BREAK POLICIES CLEARLY DEFINED

ARRIVING EARLY AND FAMILIARIZING ONESELF WITH THESE RULES CAN HELP CANDIDATES FOCUS FULLY ON THE EXAM.

AFTER THE EXAM: LICENSING AND RENEWAL

UPON PASSING THE PSI NC GENERAL CONTRACTOR EXAM, CANDIDATES PROCEED WITH THE FINAL STEPS TO OBTAIN THEIR NORTH CAROLINA GENERAL CONTRACTOR LICENSE.

RECEIVING THE LICENSE

THE LICENSING BOARD ISSUES THE OFFICIAL GENERAL CONTRACTOR LICENSE AFTER CONFIRMING EXAM RESULTS AND ANY ADDITIONAL REQUIREMENTS, SUCH AS PROOF OF INSURANCE OR BONDING. LICENSED CONTRACTORS RECEIVE DOCUMENTATION THAT AUTHORIZES THEM TO OPERATE LEGALLY WITHIN THE STATE.

LICENSE RENEWAL AND CONTINUING EDUCATION

GENERAL CONTRACTOR LICENSES IN NORTH CAROLINA REQUIRE PERIODIC RENEWAL, TYPICALLY EVERY TWO YEARS. RENEWAL OFTEN INVOLVES:

- PAYMENT OF RENEWAL FEES

- COMPLETION OF CONTINUING EDUCATION COURSES FOCUSED ON UPDATES IN CONSTRUCTION LAW, SAFETY, AND BEST PRACTICES
- MAINTAINING PROPER INSURANCE COVERAGE
