- USE DOUBLE SPACING THROUGHOUT THE REFERENCE LIST.

- USE A HANGING INDENT FOR EACH REFERENCE (THE FIRST LINE IS FLUSH LEFT, AND SUBSEQUENT LINES ARE INDENTED).

2. AUTHOR NAMES

THE APA MANUAL EMPHASIZES THE IMPORTANCE OF ACCURATELY REPRESENTING AUTHORSHIP. HERE ARE SOME KEY POINTS REGARDING AUTHOR NAMES:

- LIST AUTHORS BY THEIR LAST NAME FOLLOWED BY INITIALS (E.G., SMITH, J.D.).
- FOR WORKS WITH MULTIPLE AUTHORS, USE AN AMPERSAND (&) BEFORE THE LAST AUTHOR'S NAME (E.G., SMITH, J.D., & JONES, M.K.).
- FOR WORKS WITH UP TO SEVEN AUTHORS, LIST ALL AUTHORS; FOR MORE THAN SEVEN, LIST THE FIRST SIX FOLLOWED BY AN ELLIPSIS (...) AND THEN THE LAST AUTHOR'S NAME.

3. PUBLICATION YEAR

THE PUBLICATION YEAR IS ESSENTIAL FOR UNDERSTANDING THE CONTEXT OF THE RESEARCH. FORMAT IT AS FOLLOWS:

- PLACE THE YEAR IN PARENTHESES IMMEDIATELY AFTER THE AUTHOR'S NAME (E.G., SMITH, J.D. (2020)).
- FOLLOW THE YEAR WITH A PERIOD.

4. TITLES OF WORKS

PROPER TITLE FORMATTING IS CRUCIAL IN APA STYLE. NOTE THE FOLLOWING GUIDELINES:

- CAPITALIZE ONLY THE FIRST WORD OF THE TITLE AND SUBTITLE, AS WELL AS ANY PROPER NOUNS (E.G., THE EFFECTS OF SOCIAL MEDIA ON COMMUNICATION).
- ITALICIZE BOOK TITLES AND JOURNAL NAMES.
- FOR JOURNAL ARTICLES, INCLUDE THE TITLE OF THE ARTICLE IN PLAIN TEXT, FOLLOWED BY THE TITLE OF THE JOURNAL IN ITALICS.

5. SOURCE INFORMATION

WHEN CITING BOOKS, ARTICLES, OR WEBSITES, INCLUDE THE FOLLOWING SOURCE INFORMATION:

- FOR BOOKS: INCLUDE THE PUBLISHER'S NAME (E.G., NEW YORK, NY: RANDOM HOUSE).

- FOR JOURNAL ARTICLES: PROVIDE THE VOLUME NUMBER IN ITALICS, ISSUE NUMBER IN PARENTHESES (IF APPLICABLE), AND PAGE RANGE (E.G., JOURNAL NAME, 12(3), 45-67).
- FOR WEBSITES: INCLUDE THE DOI (DIGITAL OBJECT IDENTIFIER) IF AVAILABLE; IF NOT, PROVIDE A URL (E.G., RETRIEVED FROM HTTP://WWW.EXAMPLE.COM).

IN-TEXT CITATIONS ACCORDING TO APA 6TH EDITION

IN ADDITION TO FORMATTING YOUR REFERENCE LIST, PAGE 52 OF THE APA MANUAL COVERS IN-TEXT CITATION RULES THAT ARE INTEGRAL TO APA STYLE. IN-TEXT CITATIONS ALLOW YOU TO CREDIT SOURCES WITHIN THE BODY OF YOUR WORK.

1. BASIC FORMAT

THE BASIC FORMAT FOR IN-TEXT CITATIONS INCLUDES:

- FOR A SINGLE AUTHOR: (AUTHOR'S LAST NAME, YEAR) (E.G., SMITH, 2020).
- FOR TWO AUTHORS: (FIRST AUTHOR'S LAST NAME & SECOND AUTHOR'S LAST NAME, YEAR) (E.G., SMITH & JONES, 2020).
- FOR THREE OR MORE AUTHORS: (FIRST AUTHOR'S LAST NAME ET AL., YEAR) (E.G., SMITH ET AL., 2020).

2. DIRECT QUOTATIONS

WHEN QUOTING DIRECTLY FROM A SOURCE, INCLUDE THE PAGE NUMBER IN YOUR CITATION:

- FORMAT: (AUTHOR'S LAST NAME, YEAR, P. PAGE NUMBER) (E.G., SMITH, 2020, P. 15).

AVOIDING COMMON PITFALLS

PROPER CITATION CAN BE COMPLEX, AND MANY INDIVIDUALS MAKE FREQUENT MISTAKES. HERE ARE SOME COMMON PITFALLS TO WATCH OUT FOR:

- **INCONSISTENCY:** ENSURE THAT ALL CITATIONS IN YOUR REFERENCE LIST MATCH THE CITATIONS USED IN YOUR TEXT.
- **MISSING INFORMATION:** ALWAYS DOUBLE-CHECK THAT YOU HAVE INCLUDED ALL NECESSARY DETAILS (AUTHORS, PUBLICATION YEAR, TITLE, ETC.).
- **PUNCTUATION ERRORS:** PAY CLOSE ATTENTION TO PUNCTUATION, PARTICULARLY WITH COMMAS, PERIODS, AND AMPERSANDS.
