THE ROLE OF MATRICES IN QUANTUM MECHANICS

IN QUANTUM MECHANICS, PHYSICAL SYSTEMS ARE OFTEN REPRESENTED MATHEMATICALLY USING STATES AND OPERATORS. THIS IS WHERE MATRICES COME INTO PLAY. STATE VECTORS AND HILBERT SPACES

1. STATE VECTORS: A QUANTUM STATE CAN BE REPRESENTED AS A COLUMN VECTOR, KNOWN AS A STATE VECTOR, DENOTED AS $|\psi\rangle$. FOR INSTANCE, IN A TWO-LEVEL SYSTEM (LIKE A SPIN-1/2 PARTICLE), THE STATE VECTOR MIGHT LOOK LIKE THIS:

$$|\psi\rangle = \begin{pmatrix} A \\ B \end{pmatrix}$$

WHERE $\langle A \rangle$ AND $\langle B \rangle$ ARE COMPLEX NUMBERS REPRESENTING THE PROBABILITY AMPLITUDES OF THE SYSTEM BEING IN EACH STATE.

2. HILBERT SPACE: THE COLLECTION OF ALL POSSIBLE STATE VECTORS FORMS A HILBERT SPACE, A MATHEMATICAL STRUCTURE THAT ALLOWS FOR THE MANIPULATION OF THESE VECTORS AND THE CALCULATION OF PROBABILITIES.

OPERATORS AND OBSERVABLES

OPERATORS IN QUANTUM MECHANICS ARE MATHEMATICAL ENTITIES THAT CORRESPOND TO MEASURABLE QUANTITIES. THEY CAN BE REPRESENTED AS MATRICES, ACTING ON STATE VECTORS TO YIELD NEW STATE VECTORS.

- EXAMPLE OF OPERATORS:

- THE POSITION OPERATOR $\langle \hat{x} \rangle$ MIGHT BE REPRESENTED IN A SIMPLE ONE-DIMENSIONAL SPACE AS:

$$\langle \hat{x} \rangle = \begin{pmatrix} 0 & 1 \\ 0 & 0 \end{pmatrix}$$

- THE MOMENTUM OPERATOR $\langle \hat{p} \rangle$ COULD BE EXPRESSED AS:

$$\langle \hat{p} \rangle = \begin{pmatrix} 0 & -i \\ 0 & 0 \end{pmatrix}$$

THESE MATRICES ACT ON STATE VECTORS TO GIVE THE EXPECTED VALUES OF THE CORRESPONDING OBSERVABLES.

THOMAS F. JORDAN'S CONTRIBUTIONS
