LOOK FOR COURSES THAT ARE ACCREDITED AND RECOGNIZED BY YOUR STATE'S REAL ESTATE COMMISSION.

3. UTILIZE STUDY MATERIALS

THERE ARE NUMEROUS STUDY MATERIALS AVAILABLE, INCLUDING TEXTBOOKS, ONLINE COURSES, FLASHCARDS, AND PRACTICE EXAMS. SOME POPULAR RESOURCES INCLUDE:

- REAL ESTATE TEXTBOOKS SPECIFIC TO YOUR STATE'S LICENSING REQUIREMENTS
- ONLINE STUDY GUIDES AND VIDEO TUTORIALS

WHAT TO EXPECT ON EXAM DAY

CANDIDATES MUST BRING VALID IDENTIFICATION, TYPICALLY A GOVERNMENT-ISSUED PHOTO ID, TO THE TESTING CENTER. SOME STATES MAY HAVE SPECIFIC ID REQUIREMENTS, SO IT'S ESSENTIAL TO CHECK WITH THE STATE REAL ESTATE COMMISSION BEFOREHAND.

3. FOLLOW CHECK-IN PROCEDURES

UPON ARRIVAL, CANDIDATES WILL GO THROUGH CHECK-IN PROCEDURES. THIS MAY INCLUDE BIOMETRIC IDENTIFICATION, SUCH AS FINGERPRINTING OR PHOTOGRAPHING, AND A SECURITY SCREENING OF PERSONAL ITEMS.

4. UNDERSTAND THE TESTING FORMAT

AFTER THE EXAM: NEXT STEPS

ONCE CANDIDATES COMPLETE THE REAL ESTATE EXAM, THEY WILL RECEIVE THEIR SCORES IMMEDIATELY. IF THEY PASS, THEY CAN THEN PROCEED WITH THE LICENSING PROCESS, WHICH MAY INCLUDE:

1. SUBMITTING A LICENSE APPLICATION TO THE STATE REAL ESTATE COMMISSION
2. COMPLETING ANY ADDITIONAL REQUIREMENTS, SUCH AS BACKGROUND CHECKS
3. PAYING APPLICABLE LICENSING FEES

IF CANDIDATES DO NOT PASS THE EXAM, THEY CAN REVIEW THEIR SCORE REPORT TO IDENTIFY AREAS FOR IMPROVEMENT. MOST STATES ALLOW CANDIDATES TO RETAKE THE EXAM AFTER A WAITING PERIOD, SO THEY SHOULD USE THE TIME TO ENHANCE THEIR KNOWLEDGE AND SKILLS.
