TEST-TAKING STRATEGIES

KEEP AN EYE ON THE CLOCK DURING THE EXAM. IF YOU FIND YOURSELF STUCK ON A QUESTION, MOVE ON AND COME BACK TO IT LATER IF TIME PERMITS. THIS ENSURES YOU ANSWER AS MANY QUESTIONS AS POSSIBLE.

4. STAY CALM AND CONFIDENT

EXAM DAY CAN BE STRESSFUL, BUT IT'S IMPORTANT TO STAY CALM. PRACTICE RELAXATION TECHNIQUES SUCH AS DEEP BREATHING OR VISUALIZATION TO MAINTAIN A POSITIVE MINDSET. CONFIDENCE CAN GREATLY INFLUENCE YOUR PERFORMANCE.
