OVERVIEW OF SACRAMENTO COUNTY SMALL BUSINESS GRANTS

SACRAMENTO COUNTY SMALL BUSINESS GRANTS ARE FINANCIAL AWARDS PROVIDED BY GOVERNMENT AGENCIES, NON-PROFIT ORGANIZATIONS, AND PRIVATE ENTITIES TO SUPPORT THE GROWTH AND SUSTAINABILITY OF SMALL BUSINESSES WITHIN THE REGION. UNLIKE LOANS, GRANTS DO NOT REQUIRE REPAYMENT, MAKING THEM HIGHLY VALUABLE FOR BUSINESSES FACING CAPITAL CONSTRAINTS. THESE GRANTS TARGET VARIOUS BUSINESS NEEDS SUCH AS STARTUP COSTS, OPERATIONAL EXPENSES, TECHNOLOGY UPGRADES, AND RECOVERY FROM ECONOMIC DISRUPTIONS.

MANY GRANTS IN SACRAMENTO COUNTY FOCUS ON PROMOTING ECONOMIC DEVELOPMENT, JOB CREATION, AND INNOVATION. PREPARE REQUIRED DOCUMENTATION

GATHER ALL NECESSARY DOCUMENTS, WHICH COMMONLY INCLUDE BUSINESS LICENSES, TAX RETURNS, FINANCIAL STATEMENTS, BUSINESS PLANS, AND PROOF OF OWNERSHIP. ACCURATE AND COMPLETE DOCUMENTATION IS CRITICAL FOR A STRONG APPLICATION.

WRITE A CLEAR AND COMPELLING PROPOSAL

GRANT APPLICATIONS OFTEN REQUIRE A PROPOSAL OR NARRATIVE EXPLAINING HOW THE FUNDS WILL BE USED AND THE ANTICIPATED IMPACT ON THE BUSINESS AND COMMUNITY. BE CLEAR, CONCISE, AND DATA-DRIVEN IN YOUR PRESENTATION.

MEET DEADLINES AND FOLLOW INSTRUCTIONS

PAY CLOSE ATTENTION TO APPLICATION DEADLINES AND SUBMISSION GUIDELINES. LATE OR INCOMPLETE APPLICATIONS ARE TYPICALLY DISQUALIFIED.

SEEK ASSISTANCE

CONSIDER CONSULTING WITH BUSINESS ADVISORS, GRANT WRITERS, OR LOCAL SMALL BUSINESS SUPPORT ORGANIZATIONS TO ENHANCE THE QUALITY OF YOUR APPLICATION.

1. IDENTIFY THE RIGHT GRANT PROGRAM
2. COLLECT AND ORGANIZE REQUIRED DOCUMENTS
3. DEVELOP A DETAILED BUSINESS PLAN OR PROPOSAL

4. SUBMIT THE APPLICATION BEFORE THE DEADLINE
5. FOLLOW UP AS NEEDED WITH THE GRANT PROVIDER

LOCAL CHAMBERS OF COMMERCE

CHAMBERS OF COMMERCE OFFER NETWORKING EVENTS, ADVOCACY, AND INFORMATION ABOUT LOCAL BUSINESS INCENTIVES INCLUDING GRANTS.

ECONOMIC DEVELOPMENT AGENCIES

AGENCIES FOCUSED ON ECONOMIC DEVELOPMENT IN SACRAMENTO COUNTY OFTEN ADMINISTER OR PROMOTE GRANT PROGRAMS AND OTHER FINANCIAL ASSISTANCE FOR BUSINESSES.

ONLINE GRANT DATABASES
